Be it remembered that I John Atkinson of North Carolina
Chatham County considering the uncertainty of this mortal life
and being of sound and perfect Mind Memory and Reason
do make and Ordain this my last will and Testament in manner
and form following Viz first my will is that all my just
debts together with my funeral charges be paid out of my
estate - I Give and bequeath to my wife Mary Atkinson one
bed and furniture One Blank Wheel and one Saddle for her
use and at her disposal. I also give to my wife one horse
cure and bundle of her own choosing ^{my stock} out of horses one cow
one case of drawers four sheep two plows and the necessary
grazing for them for her use as long as she remain my widow
I further give to my wife one year provisions for herself and
family I also give to my said wife my dwelling House
and the plantation on which I now live for her use during
her Natural life or so long as she shall live

I give and bequeath to my four sons James Thomas Hugh
and Robert my Tract of land in Orange County Indiana
the description and boundaries of which are ^{expressed} in a
Deed of Conveyance from Hugh Woods to myself to be equally
divided among them my above named sons to them and their
heirs forever and assigns forever

I give and bequeath to my three Sons John Samuel and
 Oliver the plantation on which I now live to be equally divided
 among them
 regard being had to the quality of Land privilege of Meadows
 water &c to hold to them the said John Samuel and Oliver
 to them their heirs and Assigns forever

I give and bequeath to my daughter Charity one bed and
 furniture one plan wheel one chest one Saddle and one Cow
 I give and bequeath to my daughter Mary one bed and furniture
 one plan wheel one Saddle worth Ten dollars one Cow and

the care of drawers that I willed to my wife my will and
 meaning is that the drawers be Mary when my wife is done with them

I give and bequeath all the residue and remainder of my house
 and kitchen furniture not willed to any particular Indi-
 -vidual to my wife and daughters namely Sarah Charity and
 and Mary to each an equal part to be divided either by themselves
 or two men and two Women of their own choosing

My will is that all my property not otherwise disposed of be
 sold by my Executors hereafter named and the proceeds
 thereof together with my Cash bonds and accounts be
 equally divided among all my children Male and female
 Keturah children drawing their Mother part and
 likewise my wife drawing a child's part

And lastly I Nominate Constitute and Appoint my Son
 John Atkinson and Son in Law Nathaniel Merwin
 Executors to this my last will and Testament in Witness
 whereof I have hereunto set my hand and seal this
 twenty fourth day of the Tenth Month in the year of our
 Lord one thousand eight hundred and Twenty Nine
