nominate and appoint my three Sons, Abigail, M^{rs} Harris
John Harris & Henry Harris Executors to this my last Will
and Testament - In Witness whereof I have hereunto set

North Carolina do hereby make my last Will and Testament
and declare it to be the following. I Will and bequeath to my
two Sons John & Alexander M^{rs} Don the tract of land on which
I now live of three hundred acres. or also one hundred acres
of land joining a tract of land belonging to little John M^{rs} Don

and farming utensils Cows hogs Hens & Sheep as also
a Negro Wench named Margaret and a Negro boy named
Amos - my above named two sons John & Evaner
M^r Son as to pay any Debt I may happen to owe at
the time of my death as also pay to Duncan M^r Son my
son as his share of my property real or personal sixty
Dollars in six Months after my decease - my above men-
tioned two sons John & Evaner shall also pay to my son
Kinneth M^r Son fifty Dollars as his share of my property
real or personal in nine Months after my decease - my said
two sons John & Evaner shall have to pay to my Daughter
Mary Nielson twenty Dollars as her share of my property
real or personal, as also twenty Dollars to my Daughter
Catharine M^r Son as his share of my property real or personal
I will and bequeath to my son Duncan M^r Son the sum
of sixty Dollars for his share of my property to be paid as
above by my foresaid two sons John & Evaner M^r Son -
I will and bequeath to my son Kinneth M^r Son fifty Dollars
to be paid as above by the foresaid two sons John & Evaner
in full of his share of my property real or personal - I will
and bequeath to my Daughter Mary Nielson twenty Dollars
as her share of my property real or personal to be paid as
above by my said two sons John & Evaner - I will and
bequeath to my Daughter Catharine M^r Son twenty Dollars
as her full share of my property real or personal to be paid as
above by my foresaid two sons John & Evaner - And lastly I will
and bequeath to my Daughter Margaret M^r Son a Negro girl
named Anne as her share of my property real or personal - And
I hereby declare this to be my last will & Testament - In witness whereof
I have hereunto set my hand & seal this 14th day of April 1813
