grating. Whereas Joshua Hadley Sen^r of the County
Chatham and State of North Carolina calling to me
the uncertainty of time and the certainty of death
do the 8 day of the 2^d Month 1813 Publish this my
last Will and Testament in manner and form as fol-
loweth. It is my Will & Order that my body be decently
buried and a bequest that all my debts & debts due to
my Will, and I give and bequeath unto my beloved
Wife Jane Hadley one Horse or more to be her choice
and a saddle & Bridle and Bed Furniture. and one
Cow & two Sheep all to be her choice also I give
bequeath unto my beloved Wife Jane one certain
tract of Land lying on Deep River in Randolph
County, containing Fifty Acres with all the im-
provements belonging to the Mills, all which I give
her, and to her heirs & assigns forever. All my real
estate, claims and demands whatsoever I also give & bequeath
unto my beloved Wife Jane Hadley Three Hundred
and no less, as also it is my Will & Order that my
beloved Wife shall have the whole profits of my home
Place during her natural life or while she remains
my Widow, and it is my Will when either should
happen that then the whole Place then should come
to my son Joseph by his pay the sum of Five
hundred Dollars on which condition I give and
bequeath unto him and unto his heirs & assigns

and it is my Will and Order that all my Children ²⁷²
I shall name hereafter shall have the sum of one hundred
Dollars each that is to say Jeremiah Piggott and Sarah
Thomas Hadley Simon Hadley, William Hadley, John
Hadley, Nathaniel Camaras and Mary to Connathan
Hadley, Jacob Hadley, Joshua Hadley and Joseph
Hadley and Jeremiah Hadley and it is my Will and
Order that Hugh Mosley shall have one dollar, and it is
my Will and Order that Hugh Mosley's Children shall have
the sum of thirty Dollars each, that is to say James, Mary,
Mary Thomas and Elizabeth, and it is my Will and Order
that my two daughters Katharine Dixon and Patience
Piggott and their husbands viz shall have two hundred
Dollars each. So that that is to say two hundred Dollars
to each Dixon & Katharine and two hundred Dollars to
Benjamin Piggott and Patience and lastly I constitute
and appoint my beloved sons Thomas Dixon to be my
Executor to this my last Will and Testament, and for their
services therein I allow them Fifty Dollars each and the
rest of my Children whose names is before mentioned that
is to say Thomas, Simon, William, John, Nathaniel Camaras
and Mary, Jeremiah Piggott & Sarah & my son Jeremiah
Connathan, Jacob, Joshua and Joseph shall have an
equal division of the remaining part of all my estate
after all my debts and legacies are paid that is to say
mentioned. Given with 8th day of 2^d month in the year of
our Lord 1813. as witness my hand & the day before before
mentioned in presence of us
