at my hand and affixed my seal the day and date above
written Signed sealed and acknowledged in Presence of

tend his homely and make and cultivate the land so as
to make a sufficient support for his during his life
Further It is my Will that my Executors sell all my Property
of every kind except one feather bed and furniture and each
of the Proceeds of said sale pay the said of said debts and
personal charges and all the money that is over and pay over
unto my beloved wife Ann as for the tract of land

I sold to me an M. Thomson It is my Will that if he
should buy up them notes I should ask him that my Executors
make him a gift if he should fail I Give and bequeath the said
land unto my son just and after his death unto William Nott
the said land as the of said land is firm and I hereby make
and ordain my worthy friends Jacob Nelson & Nathaniel Nott
of this my last Will and Testament In witness whereof the
said Ebenezer Brown here to this my last Will and Testament
set my hand and seal the day and date above written Signed sealed
and delivered by the said Ebenezer Brown the testator at last will &
