Cotton wheel cards Earthen Ware and pewter all divided by my wife
and young son Myke Willson Junior. Item at the death of my wife
I give and bequeath the same to my daughter Melly Thraill hill
Item also at the death of my wife I give my Grand Child Nancy
Christian one Coward. Item I give and bequeath my son
Mychael Willson Junior one horse Saddle and bridle one
black cow seven head of hogs two pots and hooks with
all the rest of my household furniture together with
all of my working tools and I doe ordain and
Constitute Mychael Willson and Leffe Thraill hill

Executors of this my Last will and Testament and do
thence certify dissolve revoke and disannul all and every
other former Testament will requests and Executors by me in
any wise before named Willed this and no other to be my
Last will and Testament in Witness hereof I have set my

possession of my plantation and other things mentioned
durran her life or widds three fully to person
I leave to my son Thomas and Lizabeth and Elizabeth
and James Bullard all my children five shilling
at my death well beloved wife death the plantation
and all other things belonging to it or me to be sold
and Equally divided amongst my six children I
leave my loved wife and my son Thomas
Bullard my holy and sole my Executors of this
my last will and Testament in any before
this time mentioned and bequeathed this this and
no other to be my last will and Testament in
in witness whereof I have here on last my
hand and Seal the day and year above written
Signed Sealed and delivered by the said his last
will and Testament in the presence of us
