

In the name of God Amen, I Isaac Mann of North Carolina, Chatham County being of sound mind and perfect memory (blessed be God) do this twenty fifth day of February in the year of our Lord, one thousand eight hundred and thirty six, make and publish this my last will and testament in manner following, that is to say first, I give and bequeath to my son Sarch Mann, a parcel of land lying on the north west side of Bloody Creek beginning on a dogwood then running east seventy five poles to a black oak then south thirty four poles to white oak and hickory, then east to three poles degrees, north two hundred poles to a star and hickory, then north twenty three degrees, west six to four poles to a gum and maple, then west sixteen poles to a Spanish oak, then north five poles to a dogwood, then west seventy four poles to a dogwood then north thirty two poles to a post oak, then west one hundred and a five poles to a post oak, then south two hundred poles to the beginning, containing two hundred acres by computation.

Secondly, I do will and bequeath to my beloved wife Sarah, a reasonable support out of the remaining part of my lands and perishable during her natural life or widowhood.

Thirdly, I do will and bequeath to my other children that is to say Frederick Mann and daughters including that is to say, Elizabeth Mary Spicer, Helen Sarah, Maria Rachel and Nancy all the remaining part of my personal estate to be equally divided among them as common heirs.

I do hereby make and ordain my worthy friend Oron Alston, Executor of this my last will and testament. In witness whereof I the said Isaac Mann have to this my last will and testament set my hand and seal the day and year above written.

I, Kelly Hooshee of the County of Chatham and State of North Carolina being of sound mind and memory but considering the uncertainty of my earthly existence do make and declare this my last will and testament in manner and form following, that is to say, first that my Executor hereinafter named shall provide for my body a decent burial suitable to the wishes of my relatives, and friends and pay all funeral expenses together with just debts however and to whosoever owing out of the moneys that may first come to hand into his hands a part of my estate, I give first to William Emory, I give two beds and furniture, I give my cousin James Webster one covered bed that has red in it one decanter & a side of leather worth a dollar & one pine table painted tilt & one stone pot. I give all remainder of Chair to Kelly Corsett, I give to Richard Webster, son, one decanter, cut glass & one book & one ~~unity~~ counterpin his choice, I give to Kelly Hooshee one figured counterpin.

I give to Stephen Moore one large water Stom, I give to Patsy Coal one tilt
I give to Elizabeth Webster one tilt
I give to Mary Poe one middle size dish and one water and bread basket
I give to Kelly Elmore one fork her choice

Storn, I give to Nelly Webster one half of my clothes
 & she to divide the other half betwix your two
 sisters, Storn I give to Malaney Webster one calico
 frock, Storn I give to Annah Stone one of my
 candle stand and pinners

Storn I give to Elizabeth Elmore, one nutmeg
 grater, Storn I give to Lily Duckner, one toilet, Storn
 I give to Aggy one pair of bed steads straw bed
 one bead quilt & counterpin & one coat & tin box

Storn I give Dilly one counterpin and teakettle

And lastly I do constitute and appoint my
 trusty friends Thomas Rogers and James Webster
 my lawfull exccutors to all intents and purposes
 to execute this my last will and testament accord-
 ing to the true intent and meaning of the same
 and every part and clause thereof thereof, here-
 by revoking and declairing utterly void all other
 wills and testaments by me heretofore made,

 day of March A. D. 1808
