whereon she now lies to have & to hold her & her
heirs in fee simple forever - Item - I give & devise to
my fourth daughter Susannah Graven wife of Eli Graven

all that tract of land wherein I now live to have & to hold her & her heirs in fee simple forever.

Item - My will & desire is that all the residue of my estate (if any) after taking out the devise above mentioned shall be sold and the debt owing to me collected and if there shall be any surplus over and above the payment of debts and expenses that such surplus shall be sold and equally divided & paid over to my four daughters in equal proportion share and share alike like them and each to convey of them, then executors Administrators I apportion absolutely forever. I do hereby constitute and appoint my three youngest sons in law Joseph Cooper Eli Brown & Uriah Benson my lawful Executors to all intents & purposes to execute this my last Will & Testament according to the true intent & meaning of the same and every part and clause thereof hereby making up and declaring utterly void all other wills & testaments by me heretofore made in writing whereof I this day Solomon Dorott do hereunto set my hand and seal this 4th day of May A. D. 1842.
