of the Body and knowing that it is appointed for all men
one to die do Make And Ordain this my last will and
Testament in Manner and form following First I Order
that All my Just debts together with my funeral Charges
be paid out of my estate the remainder of which I will
And bequeath in the following Manner First to my beloved
wife Sarah Dixon I give and bequeath a piece of land
lying on the South Side of Camp Creek adjoining Peter
Hout David Hout and others for her Use I also give and
bequeath unto my beloved wife the North Side of the plan-
tation wherein I now live Beginning at the South Side
fork thereof running north with my land until it strikes
Solomon Swarts line together with the Buildings thereon for
her Use until my daughter Hannah shall arrive to the age
of twenty ^{seven} ~~and~~ years - Secondly I give and bequeath unto
my daughter Hannah All the plantation wherein I now
live adjoining John Stuart Solomon Stuart Jps Dixon
and others with all the Appurtenances thereunto belonging
I also give and bequeath unto my daughter Hannah
All Bonds and Notes belonging to my estate Thirdly I
give and bequeath All my Stock of whatever Nature she
be unto my beloved wife for her Use until my daughter
Hannah shall arrive to the Age of twenty ~~and~~ years and
then the same to be my daughter Hannahs
Fourthly I give and bequeath my Dub Clock Watch
and Naggon to my beloved wife for her Use until my

daughter Hannah shall come to the age of twenty
 One year Finally I give and bequeath to my beloved
 wife all the property that I received with her for her.
 Use and let her dispose

Lastly I give and bequeath to my beloved wife all
 my plate linen and other implements of husbandry to
 gether with all my house hold and kitchen far
 niture of whatsoever nature it be for her Use until my
 daughter Hannah shall come to the age of twenty
 One year And then the same to be my daughter Han
 nahs - Twentiethly I give and bequeath unto my beloved
 wife all my Grain of every description together with
 all my other provisions for her Use & finally my will
 is that my daughter Hannah shall have a liberal
 School education And the expenses of which to be defray
 ed out of her own legacy Thirtiethly in Case my
 daughter Hannah shall die Under age or without issue
 then in that Case my will is that all my real estate
 be equally divided Amongst my Brothers and
 Sister Sons And all my personal estate to be equally
 divided Amongst my Brothers and Sister daughters
 And lastly I Recommend Constable and Appoint
 my Trusty Friends Benjamin Dixon and Asa Dixon
 whole and sole executors of this my last will
 And Testament in witness whereof I have
 signed at my hand and seal this thirtieth

stock as the Executors think necessary during her Natural
life or widowhood After her death or Marriage the same
to be equally divided between my two sons George Dism-
ukes and Charles Dismukes I give to son Eliza Dismukes
Children one Negro girl named Leandra Say that my
daughter Nancy Sealock has had her part My son William
Dismukes has had his part My Grandson Stephen Poe
has All I intend giving him which the dad of Gift
will show as recorded in Court. Item I Give my
son Alexander Dismukes a Negro Man named Humphrey
& one tract of land on Harlands Creek Joining Allen
Goodwin and others Containing One hundred and fifty
Acres Item I Give to my Executor Stephen Moore
and Gray M Dismukes one Negro girl woman
