In the Name of god Amen I William Cole In of the County
 of Chatham & State of North Carolina being weak in body
 of sound and perfect Mind and Memory before the
 Almighty god for the same do make and publish the My
 last will and testament in Manner and form following
 first I send unto My beloved wife Elizabeth Cole the land
 and plantation whereon I now live containing two hundred &
 thirty two and one half Aers and five Negro Slaves by the
 Name of Solomon the Peter called Old Peter & Little Peter the
 wife of Old Peter & Juliana All My house hold & kitchen
 furniture the plantation Utensils and stock of All kinds the
 All My crop on hand or in hand I know all My corn grow-
 ing in My fields My wheat that is now in stacks by
 other with My cotton and potatoes and every other
 article of the present Crop My best debts to be paid
 out of the Above named perishes after My death
 during her life time

secondly I give and bequeath unto My eldest son Reuben Cole
 one Negro girl slave which which said girl of having a tooth
 had been sold by him My said son Reuben he sold her in his
 presence by the Name of Phoebe thirdly I give and bequeath
 unto My son Isaac Cole one Negro woman slave by the Name of
 Charlotte and her four Children by the Name of Perry Joseph
 Winifred & Jeremiah the whole of them now in the possession of
 him My said son Isaac fourthly I give and bequeath
 unto My third son William Cole one dollar
 fifthly I give and bequeath unto My son Isaac Cole trustee
 for My son William Cole the above mentioned two hundred &
 thirty two and one half Aers of land After the death of My said
 wife Elizabeth Also one Negro girl by the Name of Juliana be-
 -ing one of the above mentioned slaves Also the one third part
 of all the balance of property loaned to My said wife Eliza-
 -beth during her life or rather the one third part of all the
 property which may be remaining at her death the said
 trustee obliging himself to pay over the said profits of land
 or property unto My said son William Cole or otherwise value
 of it in supporting his wife & Children during the lifetime of
 My said son William Cole and at his the said Williams death
 the said trustee to be hereby Oblige to equally divide between
 the lawful begotten Children of him My said son William Cole
 the said lands & property which he the said trustee had in
 trust Sixthly I give and bequeath After the death of My said
 wife Elizabeth unto My son Reuben Cole the one third part
 of all the property which I have above loaned to My said
 wife Elizabeth the said land Negro girl excepted I

Then the one third part of as much as may be remaining
at her My said wife Elizabeths death —

Seventhly I give & bequeath unto My said son Isaac Cole after
the death of My said wife Elizabeth the one third part of all
or as much as may be remaining at her said death the property
bequeathed to her My said wife Elizabeths life time the said
land and Negro girl accepted & I do hereby Attest My
son Isaac Cole sole executor of this My last will and
testament — hereby revoking all former wills by me made
in witness whereof I have hereunto set My hand and seal
this the 1st day of August in the year of our Lord 1833
