This is my Last Will and Testament written December
18th 1909. To my dear relatives love and good wishes.

I have not much to give, but I want to tell you in
my own way who I want, should have certain articles.

I shall not try to make each one's remembrance of
the same value, so don't look at them purely, from
a money value standpoint.

After every debt is paid that this last sickness
has cost high, and any Board bill that is behind,
and my Church dues (at fifty cents a month) are all
settled up, to the time of my death. These are all
the money debts I owe. When they are paid, I want
the balance of all money due me on the Notes I
hold, to be evenly divided, between my husband, H. S.
Hayes, and my two brothers Lawrence F. Beal and Ralph
R. Beal, and my two sisters Mary F. Beal, and Amanda
C. Hayes. Each one sharing just alike.

Now for some of my smaller items. My Table
Silver that is marked with my initials (L. A. H.)
is to belong to my niece Lela Amanda Hayes. The
Teaspoons that I have that belonged to my grand-
father are to belong to my sister, Amanda C.
Hayes. The Tea Knives and Forks are to belong
to Kate H. Hayes. (The Dinner Knives and forks
are to belong to Hattie M. Hayes.) (I want brother

Ralph to have my Hemstiched Table Cloth and Napkins that match in figure, (Lily of the Valley) you and Mary use them and enjoy them (as much as I enjoyed making them.)

My Encyclopedia Britanica, 28 Volumes, is to finally belong to Hugh William Hayes. I hope it may be a great source of pleasure and knowledge to the whole family while they remain together. Hugh W. your grandfather prized these books very highly, and I consider they are by far, my best gift for any one.

I have a Readle book covered with red leather, it was made and given to me, by my Aunt Josie Siler. I want Lucy Morgan to have it. and I also have a Pin cushion top, worked in Darned net, that I want Laura Morgan to have, so they may each have a bit of work their Grandmother did, herself. (I pieced a quilt that I call the (3), as there are thirteen small bits in each small block, then these blocks are pieced into a (double dice). It is for Anna M. Morgan, my namesake. The quilt was intended for her mother and herself.)

My nice breast Pin, that Elisha Hayes gave me, is for his wife, Nellie. I want you to prize it both because your husband picked it as being pretty; and because I have enjoyed wearing it so much. May you enjoy it a long long time.

I want Mary Beal to have my side board and the set of scarfs and doilies for it, that I laid off in Oak Leaves, and outlined in Turkey red. (I want Amanda to have the bookcase I brought from Fathers, also my Wardrobe. I want Ralph Beal Jr. to have my Kitchen Cabinet Table. I think his wife will like it to use, it is so handy and saves one so many steps.)

I think Kate Hayes being mothers oldest grand-daughter is likely best entitled to mothers Ring. so I leave it for her. I hope she will (prize it and keep it all her life.)

My little ring (given me when a baby) is for

Anna Beal. and the rather light ring Aunty did own, is for Vesta A. Beal. My two small Coral Pins (alike) are for Lottie. My long gold Breast Pin with flowers Cut on it is for Ollie. I have worn it much and constant use does not seem to hurt it any. The heavier of my little silver Pins, is for Anna Beal, and the lighter one for Vesta Let her have my Pearl Belt Buckle and collar supports, My Diamond Pin I leave for Kate Hamilton Hayes. My square Cuff buttons with small diamonds, for Willie Beal, and my small gold cuff Buttons for Sister Amanda. I want Kate Brittain to have the work box her Grandpa. gave to me. And Gertrude to have the jewel box. And Lizzie to have my little Watch. I have several quilts, some quilted and some not finished. I want each Nephew and Niece and each of Hugh's Grand children to have one (1)

The quilt for John Hayes, is pieced of red and light green. (Wheel of fortune) it is ready to quilt. The 7 point star put into circle but not finally put together, it is G. E. Sr. the Double JJ for G. E. Sr. And a star put together with dark is for May Brittain leaving the handsomest ones either quilted or unquilted to be divided between Mary Beal and Amanda S. Hayes.

If Hugh wants to keep a bed, (which I cannot see that he will) I want him to have enough good cover to make him comfortable.

I want to give my Feather Bed and small Pillows, with the two pairs of hemstiched cases that fit three small Pillows to Vesta, Lottie, and Anna Beal. I give them to the three together, because I cannot divide the value evenly between them, and I want them all to take pride in having a nice bed.

I hold a deed to my Brother L. F. Beal's home place. Upon his payment to my executor (here in after named) the Notes I hold against him, or as much of said Notes as will enable my executor to make an equal division of my estate thru

in that case I hereby direct my executor to make a deed, to my Brother L. F. Beal, conveying back to him, his home place. And I now earnestly request my two sisters, Amanda L. Hayes, and Mary F. Beal to see to it, that all small items, are given to, or sent to the ones they are mentioned for. And any other articles of mine, I want them to divide among those whom the articles will benefit, as they may think best.

And I hereby appoint my Brother Ralph R. Beal as the Executor of this my last Will.

And this deponent further saith that at the same time when the said testator subscribed his name to the said last Will as aforesaid, and at the time of the deponent's subscribing his name as attesting witness thereto, as aforesaid, the said Jesse R. Carroll was of sound mind and memory, of full age to execute a Will, and was not under any restraint, to the knowledge, information or belief of this deponent. And further these deponents say not.
