I, J. K. Bryson, of Lucks, Cherokee County, North Carolina,
being of sound mind and memory, but considering the
uncertainty of my earthly existence, do make and declare this
my last will and testament in manner and form following,
hereby revoking all former Wills at any time made by me.

First: I will and devise unto my brother Golman
Bryson the tract of land on which I now live and reside,
the same being about 30 acres more or less, and lying
and being in Beaverdam Township, Cherokee County
and being known as the Oscar Rose place; said Tract of
land having been purchased by me from Oscar Rose
and the deed to same being of record in the Office of
the Register of Deeds for Cherokee County, North Carolina.
It is my will, desire and purpose that my brother
Golman Bryson shall have this tract of land in
fee simple with the full use and enjoyment and
right to dispose of same.

Second: I give, devise, will and bequeath unto
my brother Golman Bryson all of my personal
property of whatever kind and description, the
same consisting of household and kitchen furniture,
beds, quilts, bedding, cook stove, and all cooking and
kitchen utensils, and any and all articles and
property that are now in my house where I live at
this time; said personal property also including one
mare about four years old, one milk cow, one 12 gauge,
L. C. Smith shot gun, one .38 special pistol, and
all the personal property that I now have, it
being my purpose to give my brother Golman
Bryson every piece and article of personal property

that I own and possess, and shall own and possess at the time
of my death.

Third: I give, devise, will and bequeath to my wife
Mary Bryson the sum of ten (\$10.00) Dollars and I direct my
executor to pay this sum out of any money that I may
have on hands at the time of my death or to sell any
of my personal property in order to pay said sum
to my wife if the same shall be necessary.

Fourth: I nominate and appoint my friend
J. L. Rose to be the executor of my will and I
direct him to see that all provisions of this will
are faithfully carried out as I give to my executor full power
to do any and all things necessary to carry out the provisions
of this will, and it is my will and desire that J. L. Rose
shall serve as my executor without making or giving
the bond required by law.
