and testament.

Item 1. I will my immortal soul to God as I trust
for rest and peace after death, having full faith and
belief in his promises, and direct my executors, herein
after named, as soon as convenient after death to pay
all of my just debts, using for that purpose such of
my estate as they see proper, not specifically disposed
of by myself in this will.

Item 2. I give and bequeath to my beloved daughter,
Ellen Butt, residing at Blairville, Union County, Georgia
and in the event of her death before mine, then to her children
share and share alike, the following real estate, to-wit:
all of my Lewis Little place situated and located in Cherokee
County, State of North Carolina, on Nottely river, and lying
north of the public road, as now located from Blairsville,
Georgia to Bullockton, North Carolina. Also whatever interest
I may own at the time of my death in lot of land number 115,
in the ninth district and first section of Union County,
Georgia, and known as the Edge farm.

Item 3. I give and bequeath to my beloved daughter,
Iowa Gunn, residing at Isabella, Polk County, Tennessee,
and in the event of her death before mine, then to her children
share and share alike, the following real estate, to-wit:
all of the land sold and conveyed to me by Robert Bruce and his
wife on the 4th day of January 1895, the same being located
in Cherokee County, North Carolina, and on Nottely river, and
fully described in the deed from Robert Bruce and wife to my
self. Also all that part of my Lewis Little place which I now
own and not given to my daughter Ellen. It being that part of

said place on Nottely river, Cherokee County, North Carolina, lying south of the Blairsville and Cullerson public road, and north of the top of the mountain on said place. Also my house and lot on which said house is located in Isabella, Polk County, State of Tennessee, and the same in which my said daughter, Iowa and her family now reside.

Item 4. I give and bequeath to my two beloved daughters, Ellen Butt and Iowa Linn, jointly and equal terms and share and share alike, and in the event of the death of either or both of them before mine, then to their children share and share alike, that is to say the children of each to have the interest of their mother, no more and no less. All of the remainder of my property of every kind, consisting of money, debts due me, stocks and all other property of every kind no matter where located not hereinbefore given and be questioned in this will in items two and three, and as to the division of the property given in this item of this will, I direct and request that my executors hereinafter named divide the same between themselves without the aid of any court whatever in order to save and avoid that unnecessary expense.

Item 5. Having full and unlimited confidence in my said daughters, Ellen and Iowa, I appoint them executors of this my last will and testament and relieve them of giving bond or bonds, making an inventory of the assets of my estate and from making annual returns to any and all courts in any and all of the States in which my property may be situated at the time of my death.
