I also give him one half of the mineral interest in that sold to Mr Ed Miller and joining my land. I also give him all of my personal property, except one large looking glass. I give to my youngest daughter Mrs. Annie J. Bandler I give the above property on the following terms, to wit, he is to pay to Norman E. Davidson my Grandson the sum of two Hundred Dollars and pay all Expenses of my sickness and burial if he refuses to do so sell the property pay the debts and give him the balance of the proceeds.

need it more the five Herbert children. Let their mothers part and no more. she gets like her other sisters spoken of above, the land I give them lies in Beaverdam Township Cherokee County N. C. it contains some four or five hundred acres. When the land is sold each one gets as much as is coming to him or her if one hundred acres sold pay the proportionate, to each one the Herbert children, the five getting, the part their mother would have received if she had been living no more.
