and bequeath to the said George B. Brasington,

State of South Carolina, his certain promise

Not now owned and held by me, which is referred to in Item III hereof.

Item I In appreciation of his devoted kindness and aid through many years, I give and bequeath to the best friend of my beloved husband and myself, William F. Dargan, of the Town and County of Darlington and State of South Carolina, the sum of one thousand dollars (\$1,000.00).

Item II I give and bequeath to my brother and sister Charles R. Woods and Sue Woods Dargan one thousand dollars (\$1,000.00) each, and to my brothers, Samuel A. Woods and Clayton R. Woods, five hundred dollars (\$500.00) each.

Item III I authorize and direct my executors to expend so much of my estate as she will consider adequate and proper for a memorial in the town of Darlington to my beloved husband, E. Keith Dargan; but I desire no tombstone erected.

Item IV All the rest, residue, and remainder of my property, real, personal and mixed, of every nature, kind and description, that shall remain after the payment of my debts and funeral and testamentary expenses and the pecuniary legacies hereinbefore provided for, and after paying for the afore said memorial to my said husband, including all monies in bank, shares of stock, choses in action, and other property, I give, devise, and bequeath to my dearly beloved daughter-in-law the said Olive Telford Dargan, if she shall survive me, and to her heirs and executors and assigns and administrators forever; and in so doing I am but expressing in the only manner that remains to me the immeasurable love and appreciation of one whose unimpaired loyalty and
