

Record of Wills

In the name of God, Amen.

March 27 1858

I Gaad Mauny of the County of Cherokee in the State of North Carolina being of sound mind and disposing memory do make this my last Will and Testament in manner and form following that is to say that my Executors hereinafter named provide for my body a decent Christian burial and pay all my just debts out of the first money ^{which may} come to their hands out of my Estate.

Secondly I Will and bequeath to my beloved wife Emily all my Home hold and kitchen furniture all my Hogs cattle horses & other like Stock and Farming implements of whatever kind together with all my Real Estate except that part this day contracted to Ambros H Mauny & Sylvanus Mauny and excepting further what lands one hand and warts which is allotted to Prokers Grady to be used by him for his support during his Natural life and the lands willed to my wife Emily and Chatted is only for term of her natural life. My Executors hereafter will allot the land to Prokers Grady immediately if require to do so having due regard to my wife's interest

Thirdly I Will and bequeath to my beloved Son Ambros H Mauny Sylvanus Mauny & George R. Mauny to them and their heirs all my Real Estate in the said County of Cherokee with the incumbrance of my wife's life estate and with conditions expressed as follows that Ambros H Mauny ^{Sylvanus Mauny} and his heirs and twenty acres of land so contained and described in a conveyance of the date fourth of the month of the September 1848 including the dwelling house where G & W. Mauny live. It is hereby made and declared as my last Will that if my Son George R. Mauny be dead at his death then and in that case all the estate provided for him in this my Will shall be equally divided between my two Sons Ambros H. Mauny & Sylvanus Mauny & their heirs in the event of the death of Ambros H. or Sylvanus Mauny before

= the probate of this Will then respectively here later what is intended for them executes respectively. I hereby having heretofore advanced wages and other property to my Son Lewis Mauny and to my Daughter Mrs Cecilia Monow-dana wife of G & W. Mauny & Mary Malinda wife or widow of Alexander Angel Dennis I hereby declare that they and each of them are not entitled to any thing more of my Estate nor their heirs

Lastly I hereby Will and and appoint my trusty friends Ambros H Mauny and Joseph Keener to execute this my last Will and Testament hereby revoking all other paper writings purporting to be my Will

Witness my hand and seal the first day of January 1858 one thousand eight hundred and Seventy three.
