 Son of the County of Cumberland and State
 of North Carolina. Being of sound mind and
 memory (Blessed be God) do this second day
 of July in the year of our Lord one thou-
 sand eight hundred & thirty three, make
 and publish this my last Will and Testament
 in manner following. to wit. First. I give
 and bequeath to my beloved wife for and
 during the term of her natural life or
 widowhood the room at the West end of
 my dwelling house, with one good bed
 and furniture and such other furniture
 as would be necessary for a lone woman
 to furnish such a room with together with
 the framed Smoke house & the house at
 present occupied by Tom and Grace for
 her Kitchen, also the old Barn and stable
 adjoining called the fodder house and
 Lot attached with the free privilege of
 wood and water necessary and further I
 give to her the labor or service of two of
 my Slaves Jacob and Amy my Horse and
 Sij two Cows and Calves, one sow and piggs.
 Her title of all is to cease at her death or
 intermarriage - Item. I give to my
 Daughters Mary my negro man Philip and
 Rachel a girl. Item. I give to my son
 John five Dollars and to his children three
 negroes. Isaac. Malinda and Joe,

Item. I give to my son Jonathan the
 Land he lived on as laid off by Wilkinson,
 also my negro man John and his father
 David and Prigilla his mother.

Item. I give to my son Josiah the Land he lives on as laid off by Wilkinson and two negroes old George and Chike.

Item I give to my son James the Land he lives on together with four negroes to wit David, Mary, Daniel and Logan

Item. I give to my son Joseph the one half of the Land where I live with all the Land joining it that belongs to me, except the privilege before devised which is to return to him and Dickson at the death of their step mother together with five negroes. James, Rose and her three children,

Item I give to my son Dickson the one half of the Land on which I live to be equally divided between him and Joseph with five negroes, George, Frank, Inda, Solomon and Pierce.

Item. I give to my Grand Daughter Maryann Evans, Fifty Dollars.

Item. I give to my Grand Daughter Catharine Evans my Negro Man David called Dicksons Dave.

And further My will and desire is that all the Property by me owned and not devised be equally divided among my six children to Mary, Jonathan, Josiah, James, Joseph and Dickson; except Two Hundred and fifty Dollars to be applied to the education of the two youngest, And I hereby constitute and appoint two of my sons Josiah and Joseph my Executors to this my will and Testament
