In the Name of God Amen I Samuel Williams of
the County of Cumberland and State of North Carolina being sick
but in perfect mind thank God for it, and calling to mind
the mortality of a Man that he is gone to die and as touching my
Worldly estate have made and by these presents do make this my
last will and do devise my Property in the manner as follows
viz. I give unto my loved wife Phoebe Williams the Old plantation
where I formerly lived for life time, Also Five Negroes together
with their increase namely Josh, Leazar, Pegg, Joe, and Nelly
the balance of the Cattle after five Cows & Calves are taken and
the Sheep, Hogs, farming Tools, all the house hold furniture
except three Beds & furniture the riding Chari, harness & woman saddle
the horses only those each of the Girl's to have a horse apiece
when they come of age

Also I give unto my Son Harry Williams his horse & harness and
the Land that I bought of Hathaway and that joining of it and
the Negroes ~~and~~ ^{with} their increase namely Charles, Henry, Simon,
Hager, Sissy, and Amy. Five Cows & Calves and Saddles and
Bridles

Also I give unto my Daughter Isabella Williams One bed &
furniture One Saddle & Bridle & an equal share of the twelve
Negroes namely Dick, Guy, Peter, Watt, Green, Dublin, George,
Deey, Beck, Filly, Abram, & Mimmy that is one third of them and
a third of the Land where I formerly lived after my wife's death

Also I give unto my Daughter Phoebe Williams One bed &
furniture One Saddle & Bridle an equal share of the twelve
Negroes namely Dick, Guy, Peter, Watt, Green, Dublin, George,
Deey, Beck, Filly, Abram & Mimmy that is one third of them and
a third of the Land where I formerly lived on after my wife's death

Also I give unto my Daughter Peter Williams One bed &
furniture One Saddle & Bridle an equal share of the twelve
Negroes namely Dick, Guy, Peter, Watt, Green, Dublin, George,
Deey, Beck, Filly, Abram, & Mimmy that is one third of them
and a third of the Land where I formerly lived on after my wife's
death

Also I have the Oxen Waggon, Cart, Shop Tools & Mill Tools
to

kept for the use of the Mill and the office to be kept employed
until the debts are Paid and after the Debts are Paid for my
Wife Phoebe Williams to have the five Acres of Land where
now live together with the buildings, and little Mill and
the four hundred Acres that it is on her lifetime, and the
balance of the Lands lying on or near Carons Creek or Greens
to be equally divided between the four Sons, Namely Harry
Williams, Isellen Williams, Phoebe Williams and Peter
Williams - and by this present I do hereby appoint my
Wife Phoebe Williams Executor and my Son Harry
Williams Executor in which I have hereunto
set my hand and seal this Second Day of
March in the Year of our Lord one thousand
Eight hundred and five.

my last will & testament in the 3rd last line.
