God I Elias Dozier do agree this to his last & testimony in the
proper sense of the word County I give to Amy Warden four dollars
and seven ty cents due by Louis L Daugre I give to Amy Warden
Twenty dollars due from patsey Dozier I to give Susanah
Dwiger my sixty seven Dollars & twenty five cents due
from Samuel Sawyer I give to Wmey Stewart seven doll-
ars & seven shillings which she or is due I give to R. Daugre
one flat basket two hogheads and a tub I give to Amelina
Warden one wheel one bed & chest and jarre some earthen
ware I give to my sister amy Warden to do what she
pleases with I give to Amy Warden one note due from
Burnell and a pare of wool cards and the note on Burn-
ell eight dollars & and eighty one and quarter cents
To the above heirs given under my hand this the 12 day of
November 1827

of North Carolina and county of Currituck being in health
and perfect mind and memory thankst be to god for
the same, do make and ordain this my last will and
testament; first I recommend my soul to him that gave
it and my body to be buried in a Christian like burial
and as touching my worldly affairs I give and bequeath
in manner following;

Item, after my just debts being paid I give and bequeath
to my beloved wife Nancy Brabbel the whole of my estate
with in doors and without by her freely to be possessed
whom I likewise constitute, make and ordain the
sole executors of this my last will and testament
and I do hereby utterly disallow revoke and disannul
all and every other former testament will Legacies
bequests and executors by me in any ways before named will-
ed and bequeathed; ratifying and confirming this and no other
to be my last will and testament. In witness whereof I have
hereunto set my hand and seal this the thirteenth day of
March in the year of our Lord one thousand eight hun-
dred and Twenty one. I sign sealed and pronounced and public-
Caleb Tatem Jurat I did in the presence of us.
