 twenty dollars due from patsy Dozier I to give sudanah
 Chancyer my sixty seven Dollars & twenty five cents due
 from Samuel Sawyer I give to Winey Stuart seven doll-
 ars & seven shillings which she or is due I give to R. Dange
 one flake brake two hogheads and for tub I give to Amalima
 Worden one wheel one bed & chest and jarre some earthen
 wear I give to my sister amy Worden to do what she
 pleases with I give to Amy Worden one note due from
 Bunnell and a pare of wool cards and the note on Bun-
 nell Eight dollars & and eighty one and quarter cents
 To the above heirs given under my hand this the 12 day of

 in manner following;

Item, after my just debts being paid I give and bequeth
 to my beloved wife Nancy Brabbell the whole of my estate
 with in doors and without by her fully to be possessed,
 whom I likewise constitute, make and ordain the
 sole executrix of this my last will and testament
 and I do hereby utterly disallow revoke and disannul
 all and every other former testaments wills Legacies
 bequests and executors by me in any ways before named will-
 ed and bequethed; rectifying and confirming this and no other
 to be my last will and testament. In witness whereof I have
 hereunto set my hand and seal this the thirteenth day of
 march in the year of our Lord one thousand eight hun-
 dred and Nineteen ones. } sign sealed and pronounced and publi-
