Guilford and State of North Carolina being Wake in and out
of Sound mind and memory thanks be to God for the same as
the Tenth day of April in the Year of our Lord
one thousand eight hundred and nine made and drawn forth being
last Will and Testament in manner and form as followeth
I being being being Just Duly then do the Executors of all
my Real and Personal Parishable Estate unto my wife Rachel
Waley for the term of ten Years to make use of and have Support for
herself and Children and my will and desire is that my
aforesaid wife Rachel Waley shall keep my two Children Lydia
and Stephen Waley and send the aforesaid Stephen Waley to
School five Years in the term of the aforesaid ten Years if life &
health will admit without raising any Account against
my aforesaid Children Lydia and Stephen Waley within the
Limitation of ten Years

2. Upon after the Expiration of the aforesaid ten Years then I give and bequeath unto my aforesaid wife Rachel Babycorn
 Third of all my Real Estate to the said Poor Men in this simple
 Manner to wit

3. WILLM after the expiration of the aforesaid term of Ten Years then I leave unto my Son Stephen Daley all the Remainder of my aforesaid lands untill he shall come to the age of twenty-one Years and after he arrives to the age of Twenty-one then I Give and Bequeath unto my aforesaid Son Stephen the aforesaid land to him and his Heirs for ever but if my aforesaid son Stephen dies should Decease before he arrives at the aforesaid age of twenty-one Years without a lawfull Issue begotten of his body then I leave the aforesaid land unto my Daughter Lydia Daley untill she shall come to the age of twenty-one Years and after she arrives to the aforesaid age of Twenty-one Years then I Give and bequeath unto my aforesaid Daughter Lydia Daley the aforesaid land to her and hers for ever but if she should Decease before she arrives to the aforesaid age of Twenty-one Years without a lawfull Issue begotten of her body then I Give and bequeath unto my wife one fourth of the aforesaid lands I mean of the land that I lent to my Two Children to her and her Heirs for ever and the other three fourths of the aforesaid land I leave unto

my aforesaid wife during her natural life and after her death her heirs and assigns forever. And I the said Thomas do hereby certify that the said John and Frederick the aforesaid three fourths share to be divided between them legally heirs and assigns as to them and their heirs forever.

4th After the Expiration of the aforesaid ten Years then I bind unto my Daughter Lydia Bailey Jones Negro Man by the Name of Daniel Burdett and he shall come to the age of twenty one Years and after the Expiration of the aforesaid age of twenty one Years then I give and bequeath unto my aforesaid Daughter Lydia the aforesaid Negro unto her use her heirs and assigns but if she should die before she aforesaid the aforesaid age of twenty one Years without Lawfull Issue begotten of her Body then I bind the slave and benefit of the aforesaid Negro by the Name Daniel aforesaid unto my Son Stephen Bailey who he shall come to the age of twenty one Years and after he aforesaid to the age of twenty one Years give and bequeath unto my aforesaid Son Stephen Bailey the aforesaid Negro to him and his heirs for ever but if he should die before he come to the aforesaid age of twenty one Years without Lawfull Issue begotten of his Body then I bind the aforesaid Negro unto my Wife Rachel's Bailey during her Natural life and after her decease I bequeath the aforesaid Negro unto my Son Thomas Bailey, my Son Joseph Broch and Frederick to them and their heirs for ever.

I Give and bequeath unto my afore-said son Rachel half
 one third of all myovable property to be held her life, power
 and the other two thirds I Give and bequeath unto my two Children
 and Stephen to be Equally Divided between them when and where
 like to them and their heirs for ever. Last of all I do hereunto
 and appoint my Wife Rachel, Rachel and Peter Keston to be my
 for this my last Will and Testament in Witness whereof I have
 unto Set my Hands and Seal the Day and Date first Written
 Signed and Delivered
