The Last will and Testament of John Harrow
Died was Exhibited at May Term 1820.

In the name of God Amen
I John Harrow of the state of North Carolina
and County of Currituck being of a weak state
of Body But of perfect mind memory Thank
be to the Almighty God Calling to mind the mortality
of my Body and knowing that it is once appointed
for all men to die I do make and ordain this my
Last will and Testament that is to say principally
and first of all I recommend my soul to the
Almighty God that gives it and my body to the
earth to be buried in a decent Christian
Burial at the discretion of my executors nothing
doubting but to receive the same again by the
power of God that gives it as touching such
worldly Estate as when with it has pleased God
to bless me within this life I give devise and
dispose of the same in the following manner
and form first of all I give unto Elizabeth Williams
daughter of James Williams One Acre and a half
of Land which she hath got a Deed for likewise
I give her all the stock in her & my Ear mark
and Brand and I likewise give to her daughter
Elizabeth the balance of my land likewise I give
to her all my stock in her own name
and Brand like wise I give to the following ones
the sum of fifty Cents each Solomon Harrow
Ann Harrow Fanny Harrow Parcella Harrow
& Daniel Harrow That to be paid out of
my property By my executors My gun to be sold
to pay expenses. All the rest of my property which
is not here to for mentioned in my will I give
to Elizabeth Williams first named in my will
I like wise make constitute and ordain Joseph
Harrow my sole executor to this my last
will and Testament and I do hereby utterly
disallow revoke and disannull all and every
other former Testament wills I bequeath my Executor
by me in any ways before named wills and
bequeaths ratifying and confirming this and

now enter to be my last will and Testament
In witness whereof I have hereunto set my hand
and seal this the 25th of November in the Year
of our Lord one thousand Eight hundred and
Nineteen Signed Sealed and declared by the
said John Harrow as his last will and
Testament In the presence of us who in the
presence of each other have hereunto subscribed
our names
