In the Name of God, Amen, I Mary Ballentine of the County of Lewis and Clark in the said State of Ohio, do hereby certify that I have signed and sealed this Instrument of Writing to contain my last Will and Testament: first that is to say, I recommend my Soul to Almighty God that I woe and my Body to be buried in a Christian like Manner and as I shall Order it hath been, Please God to give me, I Give and Dispose in Manner & Form as follows, my Will and desires that my Well beloved Wife Mary should have the Use of the last dwelling house, one Kitchen, & one house during her Widowhood; and after I Give to my Wife Mary four Cattle her first Choice, and twenty hogs her first Choice, Also one Negro Man named Lucy and one Bed Furniture her first Choice, and all the Spinning Wheels Working & Looms and one Loom & the Truckling belonging to it the best Choice, and the best Table, and Six of the best Chairs and the best Potte & Spinning Spinn Kafe & Spinning Spinn Irons and a Pair of Mill Irons, and a Sewing Glass, and one half of the Kitchen one half of the Tubbs Pails & Piggins to her and her heirs forever: Also my Will and Desires is that my Wife Mary should have the Use of my Negro Man named Loom during her Widowhood Also my Children have & share of during my life: My Widowhood and also one Parcel during her Widowhood, and the same belong in to it; and Sea Kettle & Stove to my Wife Mary & her Heirs forever: I Give and Bequeath unto my son Joseph Ballentine and James Ballentine the Sums and Portion wherein I now live to be Equally Divided between them only my son Joseph to his first Choice, to them and their heirs forever: I Give and Bequeath unto my son Henry Ballentine all the Lands Tracts of Land & Farm & Right to him and his Heirs forever.

all the Property which I bought at Windsor of the Property of
John Bennett which was consigned to the publick, to & which

one Negro Girl named Chloe to her and her heirs forever.
I Give also and bequeath unto my Daughter Mary Knight one
Negro Girl named Nathaniel to her and her heirs forever.
I Give also and bequeath unto my Daughter Lucy Ballentine
one Negro Girl named Charfellee to her and her heirs forever,
also 1/2 of my 1st Daughter Lucy Ballentines 1st half
of a Negro Woman named Egg to her and her heirs forever.
I Give also and bequeath unto my Daughter Sarah Bennetts
Negro Girl named Selvy to her and her heirs forever.
Also one half of the Negro Woman named Egg to her and her heirs
forever.
I Give also and bequeath unto my Daughter John Ballentine
one Negro Man named Tommy to her and her heirs forever
and also one Negro Girl named Dinah and one bed and
joiner and the second desk and my Folding Chair & Harness &
Saddle and the Gunner belonging to it to her and her heirs forever.
I Give also to my two Sons Joseph & James the Negro called Tom
after my Wife's marriage or Death to them and their heirs forever.
Also my Will and Testament is that the 1/2 of my two Sons
Joseph & James shall include all my debts owing to him
where I owe two to them & their heirs forever.
I Also constitute and Appoint my son Joseph my friend Samuel
Windsor my whole and sole Executor to this my last Will and Testam-
ent, to see all my Estate settled according to this my last Will and
Testament shall require as Witness my hand and Seal this 10th
Day of November 1798.
