 to this my last Will & Testament to settle all my Business
 according to this my last Will & Testament and the law shall
 require as witness my hand & seal this 8th day of July in
 the year of our Lord 1797

In the Name of God Amen I Elizabeth Farrow of the County
 of Currituck & State of N^c Carolina being weak of body but of
 sound disposing mind & memory Praise be to the almighty God calling
 to mind the none certainty of this life & it being ordained for all People
 to die I do make & ordain this Instrument of Writing to contain my last
 Will & Testament disannulling & withdrawing all other Wills & Testaments
 before made by me either by word or writing & this only to be taken as
 my last Will & Testament, first that is to wit I do commend my soul to
 almighty God that gave it and my body to be decently in a Christian like
 manner buried in a place where it shall please my Executors hereafter
 named & as to what worldly Estate it hath been please God to bestow
 above my debts I give & dispose in manner & form as followeth
 First my will & desire is that all my just debts & general charges should be
 paid in convenient time after my decease

My Will & desire is that my loving wife Christiana should have one bed and
 furniture her choice of all I have. Likewise I give unto my loving wife
 my Riding horse by the Name of Prince saddle & bridle & one large
 Chest & likewise one Cow that is in my mark I give also to my loving
 wife eight Swine Sheep to her & her heirs for ever. Then I bequeath to my
 beloved Wife Christiana my House where I now live & twenty five

one third Acre of Land with all the Improvements thereunto belong-
 ing during her Widowhood & no longer and then I give to my beloved
 Son Joseph all the Creatures that is in his mark & brand
 I have unto my Son Joseph my Desk Horn I have unto my two Sons
 Edward & Elizabeth my peckanag & Canoe & punt. Then I give unto
 my Daughter Christiana all the Creatures that is in her mark & brand
 I have unto my Son Elizabeth all the Creatures that is in his mark & brand
 Likewise I give unto my Son Ruben one Mare Colt & his last & all
 the Creatures that is in his mark. Then I have unto my Daughter Sally
 one Mare by the name of Penny & all the Creatures in her mark
 Then I have unto my Daughter Elizabeth one large Coal Saddle
 Then I have unto my two Daughters Elizabeth & Christiana one hundred
 Acres of Land to be equally divided between them joining of Elizabeth
 Farrow for Land Elizabeth on the North side where her house now stands
 & Christiana on the south side to them & their heirs and remainder of that
 tract to be equally divided between my three sons Joseph Edward
 & Elizabeth to them & their heirs for ever. Then I have unto my son
 Ruben my Plantation at Mount Pleasant with all the Improvements
 to him & his heirs & the tract to support him with all the improvements
 Then I have unto my Daughter Sally two small tracts of Land joining
 each other joining Braddles Land on heron bay to her & her heirs
 for ever the rest of D Land for her support. Then I have unto
 my four Sons Joseph Edward Elizabeth & Ruben one hundred
 Acres of Land on Mattamuskeet joining of Sally being my
 late Entry near heron bay to them & their heirs. No Slave one
 bay horse by the Name of Bell to be sold at auction to satisfy
 all lawful charges - No I bequeath my beloved wife Christiana
 all the rest of my property during of her Widowhood & no longer for
 the Maintenance of my small Children. I also constitute &
 appoint my Friend Elizabeth Farrow for my wife Christiana
 my whole & sole Executors to this my last Will & Testament & the
 Law shall require as witness my hand & seal this 10 day of August
 and in the year of our Lord 1797
