paid all my moveable Estate to her & her heirs for ever.  
I also constitute & appoint my loving wife Rachel &  
my Friend Elizabiah Farrow my whole sole Executrix  
to this my last Will & Testament to settle all my Business  
according to this my last Will & Testament and the law shall  
require as witness my hand & Seal this 8th day of July in  
the year of our Lord anno D 1797

In the Name of God Amen I Elizabiah Farrow of the County  
of Craven & State of N<sup>o</sup> Carolina being weak of body but of  
sound disposing mind & memory Plead to the Almighty God for calling  
to mind the more certainly of the life I find being ordered over for all Creable  
to die I do make & ordain this Instrument of writing to contain my last  
Will & Testament abounding & touching all other Wills & Testaments  
of me made or me either by word or writing & thereby to be taken as  
my last Will & Testament first that is to say I command my self to  
Almighty God that giveth me body to be decently interred in a Christian like  
manner buried in a place where it shall please my Executors hereafter  
named & as to what worldly Estate it hath been given to God to be disposed  
above my death I give & dispose in manner & formar following  
first my Will & desire is that all my just debts & general charges should be  
paid in convenient time after my decease -

by Will & desire that my loving wife Christiana should have one bed and  
furniture her choice of all I have Likewise I give unto my loving wife  
one Riding Horse by the name of prime saddle & bridle from large  
Chest & likewise one Cow that is in my mark I give also to my loving  
wife eight ewe Sheep to her & her heirs for ever Then I leave to my  
beloved wife Christiana my House where I now live & twenty five

some third acres of Land with all the Improvements thereto belonging  
during her widowhood & no longer while than I gave to my wife  
to my beloved Son Elizabiah with all the Improvements thereto belonging  
Item I give unto my son Joseph my Desk Item I give unto my two sons  
Edward & Elizabiah my peddler & Canoe & punt Item I give  
my Daughter Christiana all the Creatures that is in her mark & board  
Item I give unto my son Elizabiah all the Creatures that is in his mark & board  
Likewise I give unto my son Rubin one Mare call'd & for all  
creatures that is in his mark Item I give unto my daughter all  
one Mare by the name of Bonny & all the creatures in her mark -  
Item I give unto my Daughter Elizabeth one large Coal Table  
Item I give unto my two daughters Elizabeth & Christiana one hundred  
Acres of Land to be equally divided between them joining of Elizabiah  
Farrow & Land Elizabeth on the North side where her house now stands  
Christian on the south side to them & their heirs and remainder of said  
land to be equally divided between my three sons Joseph Edward  
& Elizabiah to them & their heirs I give unto my son  
Rubin my Plantation at Mount Pleasant with all its Improvements  
& him & his heirs to support him until he comes of age  
Item I give unto my daughter Sally two small tracts of Land joining  
each other joining breadth Land on her own bay to her & her heirs  
forever the rest of said Land for her support Item I give unto  
my four Sons Joseph Edward Elizabiah & Rubin one hundred  
Acres of Land on Hatteras Island joining of Sallys being my  
late entry man heron bay to them & their heirs No Horse or  
bay horse by the name of Bell to be sold at action to satisfy  
all just & all charges - NB I leave to my beloved wife Christiana  
all the rest of property during of her widowhood & no longer for  
the Maintenance of my small Children I also constitute &  
appoint my Friend Elizabiah Farrow Jr to come & take  
my whole sole Executrix to this my last Will & Testament & the  
law shall require as witness my hand & Seal this 10 day of August  
and in the year of our Lord 1797
