of Currituck in the state of North Carolina being sick
and weak of body but of sound and disposing mind and
memory and calling to mind the uncertainty of
human life and that it is appointed for man to die do
make and ordain this my last will and testament in
manner and form following Impressis give and bequeath
to my sister Dinah Poyner my land and plantation where
an I now live her and her heirs.

Item after my just debts is paid I give and bequeath to my sister
Dinah Poyner all the remainder of my property with in door
and without to her heirs.

Lastly it is my will in desire and I hereby constitute and appoint
my brother friends Hosea Hall whole and sole Executor to this
my last will and testament in witness whereof I have hereon
to set my hand and seal this the 20th day of Sept^r 1827

deceased Feby Term 1828. - In the name of God amen
I Caleb Sears of the County of Currituck & State of
Carolina being sound and disposing mind memory but
sick in body do make this my last will and testament in man-
ner and form as followeth.

I hum I give and bequeath unto my wife Abigail Sears one
negro girl named violet to her & her heirs forever. I also lend the
use of two Boys ~~one~~ Jordan & Arthur during of her natural
life also I give my wife three beds in Moyock an one where
I now live to her and her heirs and all the household and kitchen
furniture that I have in Moyock to her and her heirs
also two spinning wheels and one wooling wheel and all the cattle
which I left in Moyock to her & her heirs I also gave her
six hogs to fatten and seven shotes & twenty five barrels of
corn one mare named Jenny to her and her heirs ~~after one riding~~
Chair and chest and five ~~old~~ sitting chairs to her heirs forever
Item I give and bequeath to divide among the heirs of my
son Charles Sears deceased one negro woman ~~name~~ Sally & children
all she has now or will have to be equally divided between them
and their heirs forever. Item I give and bequeath to my son
Thomas Sears one negro man Sam to him and his heirs also
one negro woman Ally and her child Dempsey & all her increase
here after also one hundred dollars in cash or notes to him for
ever. Item I give and bequeath to my son William Sears all
the land & plantation where I now live to him and his heirs for
~~also negro boy Jeffrey to him & his heirs forever~~

~~After paying all my debts out of the estate that has not been given above~~
I give to my two sons Thomas Sears & William Sears all the residue
of my estate between them to be divided equally to them and the heirs
for ever. I nominate constitute and appoint my two sons Thomas Sears
& William Sears my & sole ~~sole~~ Executors to this my last will and Test-
ment. Signed sealed and acknowledged this to be my last will and
testament the 5th day of Oct one thousand eight hundred and twenty six
