The Last Will and Testament of James Poyner
Exhibited and proved at May Term 1825.

State of North Carolina, I in the name of God blessed
Currituck County & I James Poyner (being) in
sound and perfect mind and memory, bless God for the
same this the 16 day of February 1825 make and publish
this my last will and Testament in manner following
that to say I give my soul unto God that gave it and my
body and my body to be buried at the discretion of my friends
I then I gave unto my beloved son Robert Poyner several
of Lane beginning at the westwardly side of the pond on the line
between she and Forbes Runnning westwardly cross down sd
line to the beaver dam thence along the beaver dam a
northwardly cross thence a eastwardly cross to the pond thence
along the pond to the first station so as to contain
seven acres of Land - I then I gave unto my beloved son
James Poyner all the rest of my land to sd James Poyner
and his heirs forever I then I gave unto my beloved son
James Poyner all my stock of hogs and cattle to him and
his heirs forever - I then I gave unto my son James Poyner
all my pot iron and beds and furniture. I then I gave unto my
son James Poyner a negro woman by the name of Abby -
I then I gave unto my beloved son James Poyner all my
movable property that is not above mentioned within
doors and without - I then my will and desire is that
Thomas Poyner Juner and my son James Poyner
Executor to my last will and Testament in witness
whereof I have set my hand and seal this 16 day of
February 1825

The Last Will and Testament of John Crank
Exhibited and proved at May Term 1825.

In the name of God Amen, I John Crank of the South Branch
in the County of Currituck in the State of N. Carolina being
weak in body but perfect mind and memory, bless God to
God for the same as touching of my worldly affairs I
make and ordain this my last will and Testament in
manner following that is to say -

I then the first I bequeath to my beloved wife Ledia Crank during
of natural life or widowhood all my lands, houses, household
and Kitchen furniture of all kinds all of my Trigs hives
by the names of Pills and Harriet all one bottom colored
Lonest endeavours with all of the appurtenances thereto
of the schooner called the Seaboard with all of my
apartments thereunto belonging all of my floating
Baiting that belongs to me by sd Seaboard with all of my
stock consisting of horses, cattle and hogs also my will and
desire is that my eldest son Caleb Crank shall have one
negro girl called Harriet for his one use benefit and lawful
all fifty acres land on the head of Latabank Bay adjoining
the lands of Willson & Kes and Elijah Gibbons to him
and his heirs forever one half of the Lonest Endeavour
I also give to my said son Caleb Crank for his one use
benefit and behoof all my will and desire is that my
son Thomas Crank shall have my negro woman called Pills
to him and his heirs forever with half of the schooner called
the Lode together with all of rights of two peaces of Land
lying on Nothers But to him and his heirs forever - now
my will and desire is that if my wife Ledia Crank should
bring should bring forth and lawful in some lands by law
be it a son or daughter that the said child shall have one
half of the schooner called Lones endeavour all the land
whereon I now live with all of the improvement thereon all
one peace of Land lying on the N. Branch adjoining the lands of
Methus But containing forty four and three fourths acres to the
said child to it and its heirs and assigns forever now my will
and desire is that my son Caleb Crank and my son Thomas
Crank and my unnamed child if any should have all of
my household furniture of all kinds all of my Kitchen
furniture all of my stock of all kinds Equally divided between
thesaid three children with all of priviledges tend to them
and their heirs forever - now my will and desire is that if
my unnamed child shall not come to lawful sale the part
of my property that that is given the said unnamed child shall


shall be Equly divided between my two sons William Thomas
Branch to them and their heirs and assigns forever

and seal and witnesses this the twenty seventh day of October

The Last Will and Testament of Tact E. Therridge
Exhibited and proved at May Term 1825.

In the name of God amen: thus the right of much one
thousand eight hundred twenty three I Tact E. Therridge
of the state of north Carolina and County of Currituck
do make this my last will and testament first I
give and bequeath to my sister Mary Gilbert Therridge
shillings thereof money of this state

Secondly I give & bequeath to my sister Anna Carter after
paying my debts & supporting my mother ten acres
of Land beginning at the water on her line a half acre
wide to the back of her line & then one and a half wide
as much as will contain ten acres thirdly I give and
bequeath to my brother Adam E. Therridge forty acres of
Land and my house & twenty five acres of marsh after
paying my debts & supporting my mother her lifetime
fourthly I give to my sister Polly Gayland fifteen
acres of Land beginning at Anna Carters line and
running on the south East side to the back end of my
land as much as will contain fifteen acres after paying
my debts and supporting my mother her lifetime.

fifthly I give and bequeath to my sister morning house
decease and twenty shillings lawful money of
this state - Whereof I have hereunto set my
hand and seal the day and date above mentioned
furthermore I leave my Brother Adam E. Therridge my
sole executor - I give my close to my mother and
all I have beside
