county of Surry and state of North Carolina, being of body
but of a sound disposing mind and memory, do make and
ordain this to be my last will and Testament, in manner
and form following. — Item. I give unto my son
Andrew Bray one negro man by the name of Bone, one
feather bed, one cow and calf, six ewes and five lambs, one
cow yearling, one red steer, one set of tea cups and saucers
half dozen tea spoons, one half of the hogs, one half of
the corn, pork and fat. Item. I give unto my son
Thomas Bray one negro woman by the name of Judy
and all her increase, with his paying two hundred dollars
to the executor for him to school as he shall think
proper. William Dace my grand son, and Matilda
Dace my grand daughter. I also give unto my son
Thomas Bray one feather bed, one walnut desk, the
remainder of my sheep, all the remainder of my hogs
one half of the corn, pork and fat, one side Saddle
one bow at, one large walnut table, to him and his
kins forever. — Item. I give unto my son William
Bray one negro man by the name of Jordan, one square
walnut table, one feather bed, one pine chest, one set
tea cups and saucers and choice of hunkies to him and
his heirs forever. — Item. I give unto Sandford
Dace the sum of five shillings, to him and his heirs forever
Item. It is my will and pleasure that all the remainder of
my property should be equally divided between my three
sons Andrew Bray, Thomas Bray and William Bray, to them
and their heirs forever. I nominate and appoint my son
Thomas Bray Executor to this my last will and testament.

and state of North Carolina, being very sick and weak of body but
of a sound mind and disposing memory, thanks be given unto God,
calling unto mind the mortality of my body, and knowing that it
is appointed for all men once to die, do make and ordain this my
last will and Testament, that is to say principally and first of all
I give and recommend my soul into the hands of Almighty God
that give it, and my body I recommend to the earth to be buried
in a decent Christian burial at the discretion of my executors, with
out doubting but at the General Resurrection I shall receive the same
again by the mighty power of God; and as touching such un-
dying estate wherewith it has pleased God to bless me in this life, I
give, devise and dispose of the same in the following manner,
and form. First, I give and bequeath to my brother Lazarus Flora
all my part of the land I继承 by my father to him and his
heirs forever. Item. I give and bequeath to my sister Julia Flora
and Charlotte Flora all my parts of the perishable estate that I
inherited by my father. I do hereby ordain and appoint my well
beloved brother Lazarus Flora my executor to this my last
will and Testament. Given under my hand and seal

And knowing that it is ap-
pointed for all men once to die to make and ordain this my
last will and Testament in manner and form as follows. February
the 13 day 1815. And first of all I give to my well beloved wife
Lydia Cooper two feather beds and furniture and two cows and
calves, and two ewes and lambs and one linen wheel and one sow
and pigs and one large chest and one large iron pot, I also give
her my loom and harness &c. I also lend her her the use of my
hand mill during her life or widowhood, and then to return to
my son Benjamin Cooper. I also give to my well beloved wife
as above mentioned, all the coal and pork and yeast I have,
for the support of her and her family, that she hath at this
time with her. I give to Sally Cooper my wife's first daughter
one cow and calf and one ewe and lamb, and one linen
wheel, and if she die without heirs lawfully begotten of her
body, the same to be equally divided between my two youngest
