Item my will and desire is so that my tract called Crook on the body Island the first of the old bay more, shall belong to my daughter Nancy Daniel for her use and benefit, my will and desire is So that my tract called Crook on body Island shall belong to my daughter Sabra Abiding for her use and benefit. My will and desire is So that my Edw. called the Union be equally populated and owned between my said wife and my Son Abraham and Daniel Mason, and at my Edw. wife's marriage or death, my will is So that my said wife's share of Edw. shall be equally divided between my Edw. Son Abraham and Daniel Mason for their use and benefit. My will and desire is So that the one third part of my Edw. called the Dolphin shall be populated and owned by my Edw. wife during of her natural life or widowhood and the other two thirds to be populated and owned by my Son Abraham Mason and at my Edw. wife's marriage or death, my Edw. wife's third of Edw. shall be populated by my Son Abraham for his use and benefit. My will and desire is So that at my death, my Grand daughter Sabra shall have one negro girl called Louis for her use and benefit. My will and desire is So that my daughter Nancy Reverie shall at my death have one negro boy called Oliver for her use and benefit. My will is that my daughter Lizbeth Marion shall at my death have one negro girl called Isabel for her use and benefit. My will is that my daughter Sabra Abiding shall have one negro boy called George for her use and benefit. My will and desire is that my negro man called Savory and my black horse should be sold at public sale and the human value of the money converted to the use of raising my Son Abraham on horse, and also my riding back to be sold for like use and the money that shall remain over the three hundred dollars shall be equally divided among all my Sons and daughters for their use and benefit. My will and desire is, to that my three daughters to wit Nancy Daniel Sabra Abiding & Lizbeth Marion shall have three fourths of Common law officers for their use and benefit. My will and desire is So that all the remaining part of my estate that is not before mentioned shall be equally divided all my Sons and Daughters for their use and benefit.

My will and desire is So that my Son Daniel Mason shall have one negro boy called Joe, at my death for his use and benefit. My will is that my Son Abraham Mason shall have one negro boy called Howard at my death for his use and benefit, my will is So that all my negro and thrift shall go to the use of the household family of my own house, that shall remain with me for their use and benefit. My will is so that my negro boy Jack after my death, shall be equally divided amongst my three daughters, Nancy Daniel Sabra Abiding and Lizbeth Marion, for their use and benefit, my will and desire is that my Son Abraham shall have my long gun and Savory Marion my ride gun, my Son Daniel my musket and my Son Abraham my hunting gun for their use and benefit. My will is So that my fishing ance shall remain for the use of the house and all the flex and atten about my house I leave to the use of the house, my will is So that the path that is in a ertain way shall be given unto my Grand daughter Sabra Abiding and also the money due from Savory Marion on account of the steeple and churche and ordain my worthy sons Abraham and Abraham Mason executors, of this my will and testament, in witness whereof I the said Maurice Mason have put to this my last will and testament with my hand and seal the day and year above written, signed sealed published and declared by the said Maurice Mason the testator, as he said.
