 any other third to be laid off to William Slight joining to the Land
 of his Brother Thomas and each of the two other Sons of my
 Wife I do give unto my two Sons Solomon & Thomas and William Slight
 them equally to my two Brothers Nathan Horse and John Slight
 New Province of the Province of Virginia Money to each of them and their
 Heirs forever.
 I do also bequeath all my just Debts to be paid out of my Wives
 Estate.
 I do also give all the rest and remainder of my Estate to my
 Wife Sarah during her life or Widowhood, and at her Death
 Marriage) all of it then remaining to be equally divided among
 my Children Archibald, Solomon, Nathan, William Slight, & Sarah
 excepting one Cow by the Name of White Rock and a Bull and a

 Northern Part of my Plantation joining Francis Horse
 beginning at a blinder of Gum at the edge of the Marsh
 a Ditch then along the Ditch, and then a Strail or
 to the Main Road, then along the Main Road to
 Pipers Handge to him and his Heirs forever, Likewise
 give him a Saddle and one Feather bed
 and his Cows forever.
