heir forever. as Witness my Hand & Seal the day &
date above mentioned and I also Nominate and
appoint my friend William Taylor my whole &
sole Executor of this my last Will & Testament

In the Name of God Amen ¹¹³ Daniel McTherson of
the County of Currituck and State of North Carolina being
Sitt of body but of sound and disposing mind and Memory
do make and Ordain this my last Will and Testament in Manner and
form following that is to say

I Give and Bequeth unto my Beloved Wife Mary McTherson the
Use and benefit of all my Lands and Houses during her Natural
Life also one Horse and Cart together with all the Farming Utensils
Household and Kitchen Furniture two Cows and calves and
all the Money that is due from the Parish for Raising Nellys
Etheridge. Then I Give and Bequeth to my Son Robert
McTherson one Horse one Gun and one Saw also one half of
my Swamp Tools consisting of one Saw four paws and
two Drawing knives

Then I Give and Bequeth unto my Son George McTherson
one Cow one Gun one Saw and half my Swamp Tools consisting
of one Saw four paws and two Drawing knives

Then I Give and Bequeth unto my Daughter Mary McTherson
one Cow and one Saw

Then after the Death of my beloved Wife Mary McTherson
I Give and Bequeth unto my Son Lisa McTherson all my Land
Houses and one Gun (and after the Decease of my Wife it is
my Will that my Daughter Betsey Fish should have one Cow
and Furniture also to my Daughter Mary I Give one Cow and
Furniture and to my Daughter Jamine McTherson I Give
one Cow and Furniture also Tools and Furniture that I have given
to my Daughters they are to have after the Decease of my Mother
and I do hereby Nominate and appoint my beloved Wife
Mary McTherson my Executrix to this my last Will and
Testament Revoking and annulling all Wills heretofore
by me made Testifying and confirming this my last Will and
Testament. In Witness whereof I do Sign Seal Publish and
Declare this to be my last Will this Twentieth day of July 1797
in the year of our Lord one thousand seven hundred and
ninety seven
