 them a cow, calf & both warmy out as she can conveniently spare. Also
 my will & desire is that all the Corn, Beans, Potatoes & all other grain be
 sold what shall be wanting for the necessities use be sold & the Money to be
 used up to pay of Debt or Debts which I have contracted. Also my will & desire
 is that the above said Negro Woman if she should live till the children be able
 to take care of themselves & Franky Nichols should be dead, that she with all
 my household furniture should be sold & the Money equally divided between
 all the children of Franky Nichols, Son & Daughters. Appointing all other
 wills before by me made. I acknowledge this to be my last will & Testament
 and do hereby nominate & appoint Franky Nichols & John Townsend my
 executor & executor to settle this my last will & Testament, as Witness my
 hand and seal this day & year above written.
