Item I Give and bequeath to my son John Hutchings one hundred Acres of Land formerly belonging to John Perkins some part and the remainder of a New Survey to him and his heirs for ever.

Item I Likewise Give and bequeath to my son Nathaniel Hutchings Fifty Acres of Land both wharums formerly Lived on and where on he lives now on part of a new Survey to him and his heirs forever.

Item I Likewise Give and bequeath to my son Thomas Hutchings Fifty Acres of Land part of the new Survey joining to his brother as aforesaid and adjoining to James Gage Land, Likewise I Give one Cow and Lamb to him and his heirs forever.

Item I Likewise Give and bequeath to my son Richard Hutchings one hundred Acres of Land lying between Nathaniel Hutchings and John Gregory binding on Caleb Gregory Survey and Likewise Fifty Acres of Land part of a new Survey beginning at Campbell's Ridge and running up to the Judge's to contain Fifty Acres of Land to him and his heirs for ever.

Item I Likewise Give and bequeath to my son James Hutchings Fifty Acres of Land part New Survey joining his brother Richard, Likewise I Give to him One Horse Colt to him and his heirs for ever.

Item I Likewise Give and bequeath to my son William Hutchings Fifty Acres of Land part of a New Survey joining of my son James to him and his heirs for ever.

Item I Likewise Give and bequeath to my son Christopher Hutchings My Dwelling Plantation whereon I now live containing fifty Acres of Land more or less Likewise I Give him my Young mare Colt pleasure to him and his heirs forever.

Item I Likewise Give and bequeath to my Daughter Mary Gregory one cow

and Lamb and one sow and pigs to her and her heirs forever.

Item I Likewise Give and bequeath to my Daughter Amy Hutchings one Suffer called Molly to her and her heirs for ever.

Item I Likewise Give and bequeath to my Daughter Linner Hutchings one Suffer called to her and her heirs forever.

Item I Likewise Give and bequeath to my Daughter Elizabeth Hutchings one Suffer called Jesty to her and her heirs forever.

Item I Likewise Give and bequeath Leave the remainder of my worldly Estate with my Truly beloved wife Amy Hutchings During her Natural Life after my Just Debts are paid and after her Decease to my three small Daughters Equally to be divided between them Peggy Mary and Sarah Hutchings to them and their heirs forever.

I do hereby Constitute and Appoint Nathaniel Hutchings and John Stanley to act as my Whole and sole Executors According to Law in this My Last Will and Testament as aforesaid. Whereunto I have unto set my hand and Seal this 8th Day of November in the Year of our Lord one thousand seven hundred and seventy Nine.
