of the State of North Carolina & Currituck County being in my
perfect senses & brought of Memory thanks be to God for the
same but calling to mind the Mortality of my body do make
and ordain this and No other to be my last Will and Testament
First I recommend my soul to eternally God who gave it me
& my Body to be buried at the Discretion of my Executors
hereafter to be named I desire that my last will be punctually
paid and the remainder of my Estate I dispose of in Manner
& form following I Infirmly Give and bequeath to my
son Isaac Tiltlett all that I have already lent him or all
that he now has in his possession of my Estate to him
and his heirs for ever. Item I give to my Grandson Isaac
Tiltlett son of Isaac one Cow called Cybele and all her increase
(and fifty Acres of Land more or less which I hold in Great
County in Spring Jan Settlement up Great Alligator
River -

River adjoining the Land of John Fisher & him his
heirs for ever. Item I Give and bequeath to my son
Thomas Tiltlett the Land and Plantation whereon I now
live as far as wayes to the lands of William Edwards
to the Southward and the land of Samuel Tiltlett to the
Northward and to extend from Sea to Sound with all
the Appurtenances to the same belonging and one flock
of Sheep commonly called the house flock which is to be about
thirty head and two Cows & Calves and one Negro boy called
Lamb and all my Carpenters Tools two hunting Guns one
Grindstone one hand Mill one Dish and one Ped and
Furniture called his at this time to him and his heirs for ever
Item I Give and bequeath to my Daughter Hannah Dowdy
all that she has in possession of my Estate or all that
I have already lent her to her and her heirs for ever. Item
I Give to my Grandson Thomas Dowdy all the Cattle
that is in his Mark now in my possession to him
and his heirs for ever. Item I Give to my Daughter
Hannah Dowdy fifty Acres of Land lying between
Samuel Tiltlett Land & Beporwells Land to her and her heirs
for ever. Item I Give and bequeath to my son Samuel
Tiltlett my Negro boy called Savage and two Cows and
Calves to him and his heirs for ever. Item I Give &
bequeath to my Daughter Sarah & Thordge two Cows and
Calves now in her possession and all of my property
that I have lent her and she has now in her possession
to her and her heirs for ever. Item I Give to my
Grandson Thomas & Thordge one Negro Girl called
Catherine and one horse Colt that I have already given
him to him and his heirs for ever. Item I Give &
bequeath to my Daughter Eliza Daugh two Cows & Calves
one Negro Woman called Phoebe and all that I have
already lent her and one two year old Mare of a kind
of a Blue Torne Colours to her and her heirs for ever
Item I Give to my Thomas Tiltlett one horse called
Jack one Mare called Diamond with all her increase

from this day and one horse called Darling to him &
his heirs for ever. Item I give to my son Samuel
Tillett one Gray Mare which he has now in his
possession. Item my Will & desire is that all my great
Chap be equally divided between my three Children
by Name Thomas Sarah & Abia to them & their heirs.
Likewise my Will & desire is that all the remainder of
my Estate out Doors & in Doors be equally divided
between my six Children by Name Thomas Tillett
Cannah Cowdy Samuel Tillett Sarah Edwards & Abia
Dough and Isaac Tillett to them and their heirs forever
And I do Nominate Ordain & appoint Thomas Tillett
my son to be my whole and sole Executor to this
my last Will and Testament In Testimony whereof
I have this Tenthenth day of March 1796 signed sealed
published pronounced & declared this Instrument of
writing to be my last Will & Testament in the
presence of the subscribing Witnesses
