- 3 I Give to my Daughter Lukey one Bed and furniture one
Small spinning Wheel 1 Table 1 Weaseth and Two Cows & a
4 I Give to my son Thomas one Bed and furniture with the
Laid Bedstead also one Bay Horse & Two Cows & Calves
I Give and bequeath unto my Son Thomas that all of them Except the
Bed and furniture should be sold for the Benefit of my said
son
- 5th I Give to my said Son Thomas the Nursery of Apples Trees
I had Planted on the Land Belonging to Richard Bount
- 6th All the rest of my Property within & without Doors I Order
to be sold & the Amount after deducting necessary Charges
to be Divided between my Son Thomas Bount & my Daughter
Nancy Haughton.

Lastly I hereby appoint my Brother Joel Kinyon Executor
of this my last Will and Testament hereby Declaring &
Publishing it so to be & in Witness Whereof have here
unto set my hand and seal this 26th Day of November in
the Year of our Lords 1800

and it being Ordained for all men Once to Die do make and Ordain this
Instrument of Writing to contain my last Will and Testament first
that is to say I bequeath my soul to almighty God that Give
it and my Body to be buried in a Christian like manner and as to what
Estate it hath been Pleased God to Give me I Give and Dispose in
Manner and form as followeth — my Will With and Desire is that
I Give and bequeath unto my son Aaron Wright seventy Acres of Land whereon
he now lives to him & his heirs for Ever

Item I Give and bequeath unto my son Jonathan Wright twenty Acres of
Land whereon he now lives to him & his heirs for Ever

Item I Give and bequeath unto my son Isaac Wright the in Manner Plantation
where on he now lives on containing one hundred Acres more or less to him
and his heirs for Ever also my Will and Desire is that my said son Isaac
Wright should have one Bed & furniture one Cow & calf

Item I Give and bequeath unto my son Richard Wright twenty Acres of Land
that I bought of George Roland joining William Flory to him &
his heirs for ever also my Will and Desire is that said son Richard
Wright should have one Bed and furniture also one of the Old Houses
to him and his heirs forever

Item I Give and bequeath unto my son Solomon Wright twenty Acres
of Land joining my son Richard Wright to him and his heirs
forever also my Will and Desire is that said son Solomon Wright
should have the apple Orchard joining the Buildings also
one of the Houses one feather Bed & furniture one Cow & calf
to him and his heirs forever

Item I Give and bequeath unto my Daughter Elizabeth Ballentine
fifty Acres of Land joining my son Solomon Wright to her
and her heirs forever

Item I Give and bequeath unto my Grand son Miles Wright Ballentine
one Acre of Land to him and his heirs for Ever

Item I Give and bequeath unto my Daughter Mary Wright fifty Acres
of Land joining Littleha Lee to her and her heirs forever also my
Will and Desire is that my said Daughter Mary Wright should have
one Bed & furniture one Cow and calf one shoe saddle to her &
her heirs forever

Item I Give and bequeath to my Will beloved Wife Mary Wright all
the Remainder of my Estate in Door and out door Debts Dues &
Demands of whatsoever after Paying my just Debts

Body but of a sound memory thanks be to God for it and knowing
it is appointed for all Persons to Die I do Renounce and Declare this
to be my Last Will and Testament in form and manner as followeth
I Give and bequeath unto my Daughter Patsy Barnett all my
Wearing Clothes then all the remainder of my Property to be Equally
Divided between my Two Children John & Patsy Barnett &
if one of them should Die without Lawfull issue the Property
I shall Return put to the Other and if both should Die without
Lawfull Issue for all the Property to my Brother George Howard

I constitute & appoint my aforesaid Brother George Howard my
Whole and Sole Executor of this my last Will to settle all my
Business agreeable to this my Will and as the Law shall Direct
