clothes if she stay with me until my death
Item I give I ~~give~~ the other half of my clothes unto Nancy
and Dorcas Harris daughters of John Harris
Item I give and bequeath unto my son James B. Hallam
at my death all my property within doors and without
unto him for ever

and I do hereby nominate and appoint James B. Hallam
and Enoch L. Stephens Executors, to this my last will &
Testament Revoking all former wills that I have made
In witness whereof I have hereunto set my hand and
seal the 9th day of November in the year of our Lord 1833

In the name of God Amen I James B. Hallam of the County of
Brunswick and State of North Carolina being very sick &
weak of body but of sound mind & memory thanks be
to God do this day make and publish this my last will
and Testament in manner and form as follows:

Item I give unto my Cousin James Dorsey all the rest of my
clothes and one trunk
Item I give unto Cornelius Gregory 1/3 of my working clothes and
to Robert Payer 1/3 of my working clothes
Item I give unto my Sisters Eliza & Lucy Brumby all my Sons
to be equally divided between them
Item I give all the residue of my property within doors
and without unto the said Lucy and Eliza Brumby
to be equally divided between them

Last will and Testament and I the said James B.
Hallam do revoke all others made or well by me
made and declare this and no other to be my last
will & Testament and, no other the 21st of January 1834

The Last will & Testament of Wm. Dorsey died near published
in open Court at July Term 1834 and proven by the oath
of John Brockert one of the witnesses thereto & the hand
writing of James G. Hale the other witness thereto proven by
the oath of Solomon Ascher the Clerk Qualifyed & ordered Recorded
In the name of God Amen I William Dorsey of the County of Brunswick
and State of North Carolina being sick but of sound
disposing mind and memory helped be God do make
and ordain this my last will & Testament in manner
& form as follows: viz
First I give & bequeath unto my two sons John L. Dorsey
& William Dorsey all the property real and personal
bequeathed to me by my father John Dorsey after the
death of my mother Mary Dorsey to them & their heirs
forever

second I give the Land & Plantation on which I now live to
my beloved wife Abi Dorsey to her & her heirs forever

Thirdly I give & bequeath unto my beloved wife Abi Dorsey
two negroes John & Sam to her & her heirs forever

Fourthly I give all my other property including money, notes
Judgments of what kind or description ever real
& personal to my beloved wife Abi Dorsey to her & her
heirs forever

Item I give the Land that I bought at the Sheriff sale
that is on a Judgment returned & sold to R. W. Mathias
whereon my mother in Law Elizabeth Mathias Mathias
lives to my wife Abi Dorsey to her and her heirs forever

Item I give all the negroes that I bought at the aforesaid
 Sheriff sales that is Call Sumner Jones Eddy Lock +
 Jones to my wife Abi Dopey to her & her heirs
 forever

Item I give all the property of Every kind that I bought
 Sheriff sale of William Ma this property to my
 wife Abi Dopey & her heirs forever

Lastly I nominate & appoint my wife Abi Dopey
 executrix to this my last will & testament
 and I also appoint my wife Abi Dopey Guardian
 to my children and I hereby revoke all former
 wills by me made - Witness whereof I hereunto
 set my hand & seal this September 4th 1830
