a place where it shall please my executor hereafter named And As to
what worldly Estate I shall ^{have} I bid god to bestow me free Above my
Deserts I give And Dispose in manner And form As followeth first
my will And Desire is that all my just Debts And funeral Charges
I should be first paid in convenient time After my Decease my will &
Desire that my Loving Daughter Liza Midgett should have ninety
Dollars to be raised of my Estate to her And her heirs forever
I give to my Daughter Mary Ann Midgett ninety Dollars to be raised of
out of my Estate to her and her heirs forever I give unto Daughter
Nethany Midgett ninety Dollars to be raised out of my Estate to her
And her heirs forever I give unto my Daughter Angelica Farrow ninety
Dollars to be raised out of my Estate to her and her heirs forever
I give unto my Grand Son James Farrow twenty Dollars to
be raised out of my Estate forever I give all my lands And
the Remainder of my Moveable Estate Unto my three Sons
William Council & Henry Council & Lucy Council to them And their heirs
Forever I also constitute & Appoint my friend John Clark & my son
Edward Farrow my whole & sole Executor to this my
last will & Testament to settle my business According to this my
last will & Testament as the Law shall require

 my hand And Seal this Twenty Seventh Day of April in the year
 of Our Lord one thousand seven hundred and ninety five
