I do hereby constitute and nominate and appoint my beloved and trusty sons Bryan and Henry Kornegay as executors to this my last will and testament given under my hand and seal this the 1st day of September in the year of our Lord one thousand eight hundred and twenty six. State of N^o Carolina) I am the name of the Lord Duplin County. I God amew. I George Kornegay but being weak in body but of perfect mind and sound memory knowing it is appointed for all men over to die to make and ordain this to be my last will and Testament, first I recommend my soul to god who gave it and my body to be decently buried by my executors hereafter named and as to such worldly goods

as it has been pleased Almighty God to bless me with I dispose of as follows. First, I give and bequeath to my son George Kornegay besides the land he lives on and the other property he has already received with the negroes Tony and Charles Bob Lander and Cato to him and his heirs. Item I give unto my daughter Lavelle and her husband John Kornegay one mare and Bridle one bed and furniture and four cows and calors, all of which they have personally rec'd. I also bind unto S^e Lavelle and her husband John the following negroes (viz) Esther and all her children and one boy named Jack during my life this my will and desire is that said negroes be under the care of my son Daniel and the profits arising from them to be applied to the support of S^e Lavelle during her life and after her decease the whole of sd negro to be equally divided amongst her children. Item I give and bequeath to my son David Kornegay besides the land he lives on, the following negroes that he has in possession viz. Violet, Will, Guss and little Tom and a boy named Matthew and one hundred Dollars in money to him and his heirs. Item I give and bequeath to my two sons Basel and Jacob Kornegay all the residue or remainder of my negroes not before mentioned in this will to be equally divided between them the sd Basel and Jacob or their heirs. Item I give unto my wife Mooreen Kornegay one horse named Super and my riding chair to her and her heirs. My will and desire further is that after all my just debts be paid that my son Basel pay my son Jacob five hundred Dollars out of my Estate

and that the residue or remainder of all my
other property be it of what soever nature, it
may not before mentioned shall be equally divided
between them Sd Basel and Jacob Kornegay and
their heirs forever (except my stock of Cattle which
I give to my son Basel Kornegay and his heirs.
Lastly I nominate and appoint my two sons Basel
and Jacob Kornegay Executors of this my last will
and Testament, I declare this and this only to be my
last will and finally, I do hereby revoke and disan-
nul all former wills heretofore made. In witness
whereof I the Sd George Kornegay Senior, have hereunto
set my hand and seal this 3rd day of January A.D.
1808. Signed, Sealed, Published and Dated by Sd George

her death or widowhood then what remains to my
son James Knole and David Knole and John
Knole and Stephen Knole acc to be equally
divided among the four last mentioned boys
sworking all other wills and testaments in witness
whereof I have thuneto set my hand and seal
affixed the day and year first above written, signe,
sealed, published and sealed by the testator to be his
last will and testament in the presence of us.
And further I apoint David Carlton and my wife
Frankey Knole as executors of this my last will
