like manner &c.

I amptress I gave and Bequeath to my Beloved
Wife Mary Deloach the land that my father Wm Deloach
Francis Peyton left me in North Carolina (consisting
of section between Spring Lake and Spring Lake
and further give to my Wife Mary Deloach my share
of the land and the same to her heirs forever
I do to my Wife Mary Deloach the care of the land
and Plantation Whom I now live and my till and
all my Negroes for the Raising of the same and
the feeding of my Children during of her life

135. as a Widowhood and then to be Devided by my Executors
According to my Will Directs I further Land her my
wife Mary Deloach after my Death and funeral Expence
is Paid all my ~~House~~ ^{House} hold goods and Chattels and all my
Tenements untill my Children Come of Age and then to
be devided and Paid out by my Executors according to my Will
Directs ..

Item I Give and bequeath to my son William Deloach all the
part of my Estate I possessed him of in my life time
and Tenements Cash to be Paid him by my Executors to him
and his heirs forever ..

Item I Give and bequeath to my Daughter Annella Stiffin all
that part of my Estate I possessed her of in my life time and
Tenements Cash to be Paid her by my Executors and her heirs
forever ..

Item I Give and bequeath to my Daughter Molly Braswell all the
part of my Estate I possessed her of in my life time and Tenements
Cash to be Paid her by my Executors to her and her heirs forever ..

Item I Give and bequeath to my son Joseph Deloach that part
of Land that I possessed him of of Horse Man's Land in
my bay horse Cold spots and fine head of Cattle and also
breeding stam and one feather bed and furniture which I gave
to my daughter Anne Come of Age to be paid him by my Executors
to him and his heirs forever ..

I further gave to my son Joseph Deloach after my Death
seven or eight hundred my Regia felle and to him
and his heirs forever ..

Item I Give and bequeath to my son Samuel Deloach that Land
and Plantations that I possessed of at Littleton and
Crescent ..

186 my Hoan main and five head of cattle and five breeding
sow and one feather bed and furniture which I gave
to my son when he comes of age to be paid him by my
Executors to him and his Heirs for ever.

I further gave to my son Samuel Delouch
my Negro Nelon Soney after my Wifes Decease
or Widowhood to him & His Heirs for ever.

Item I gave and Bequeath to my Daughter Selah Delouch
five Head of Cattle & 1 feather Bed & Furniture which
I gave to my Daughter when she comes of age to be paid
by my Ex^{rs} ~~to her~~ and her Heirs for ever.

Item I gave and bequeath to my son John Delouch the Land
and Plantations that purchased of John Shingee &
my maid & 5 head of cattle and one
feather bed and furniture and five breeding sow
which I gave to my son when he comes of age to be paid
him by my Ex^{rs} to him and his Heirs for ever.
I further gave to my son John Delouch my Negro Sella
Dick after my wifes decease or Widowhood to him and
his Heirs for ever.

Item I gave and bequeath to my Daughter Hille Delouch five
head of Cattle and one feather and furniture which
I gave to my Daughter when she comes of age to be paid
her by my Ex^{rs} to her and her Heirs for ever.

Item I gave and bequeath to my son Solomon Delouch after
my Wifes decease or Widowhood the Land and Planta-
tion & 5 cow sows together with my little and Negro Girl
I gave to him and his Heirs for ever.

I have my my Negro wench *Sam* and *pat* they
 there increase after my wife's Decease or Widowhood to
 be *Equilla* Divided between my fore Sisters *Avenilla*
Huffin and *Molly Backwell* and *Lealah Deloach* and
Mille Deloach Which I have my Sisters to them and
 their heirs for ever and my Will and desire is that after
 my Death and funeral expenses is Paid that the Remai-
 nder of my Estate let it be of What Nature or Kind so ever
 it will that my wife shall have the governing and disposing
 of it to my Children or who so ever she shall think fit to do.
 Appoint my wife *Mary Deloach* and my Son *William*
Deloach *James Deloach* and *Samuel Deloach* my sole
 and exclusive Executors of this my last will and Testament
 I Witness whereof I do hereunto set my hand and
 Seal this 31th January 1768
