or parcels of landes the one where on I now live
containing three Acres and one other where
Charles Coppedge formerly lived containing
Seventy five Acres I also give and bequeath to
my said beloved wife Nancy Bobbitt one negro
woman named Abby one negro boy named -
Jacob together with all the Rest of ^{my} Horses cattle
Hogs & sheep Corn and Fodder house hold & Kitchen
furniture & plantations & utensils her life time
or widowhood I give and bequeath unto my
son Joseph R. Bobbitt my set of Black
smiths tools and my shot gun when he
arrives at Lawfull age and after the Death
of my beloved wife Nancy Bobbitt or widow-
hood, my will is for the above property which
I give to my wife, to be Equally Divided

Among my heirs to wit Joseph R Bobbitt
 Matiey Bobbitt Lucretia Bobbitt Martha
 Bobbitt Nancy Bobbitt Helen Bobbitt
 Catherine Bobbitt Vinny Bobbitt Harriet
 Bobbitt. I do here by appoint Joseph
 Lucretia and Joseph R Bobbitt my
 sole Executors of this my last will and
 testament and hereby Revoking all former
 wills by me made in witness where of I ~~do~~
 hereunto set my hand and seal this 1 day of
 December in the year of our ^{Lord} one thousand eight
 hundred and thirty five signed sealed published
 and declared by the above named Lewis C.
 Bobbitt to be his last will and testament
 in the presence of us who have hereunto
 subscribed our names as witnesses in the
