this twenty third day of December One thousand Eight-
hundred & Thirty make & Declare this my Last
will & Testament hereby revoking all others by me made
in the following manner

I. Loan to my wife Frances J. Green during her natural
life all my lands lying north of a line to be run
as follows, Beginning at a white oak, the most north Eastern corner
of ~~from~~ moon die? tract, near some large Rocks it being a corner
of mine & S.^d Moors? ~~and~~ running a straight line to a corner pine
it being a corner of Outby Davis & Nancy Shrods, in my time
also ~~of~~ ^{of} ~~the~~ ^{the} ~~Debnam~~ ^{Debnam} tract ~~near~~ ^{near} my
Spring. the balance of the Debnam tract is not to be included in
the above Loan, I also Loan to my S.^d Wife Frances, during her
natural life the following negroes & all their Increase from this
time, negroes, Linny, Lewis, Adam, Micanor, Charity, Jerry,
Sinai, & Ruffin, & after her death I ~~wish~~ give the above nam^d
negroes namely, Linny, Lewis, Adam, Micanor, Charity, Jerry,
Sinai, & Ruffin & all increase from this time, to all the
children of my S.^d Wife (by me) to be equally divided be-
tween them, to them & their heirs forever

I give unto my S.^d Wife Frances, Two horses, Three cows &
Calves, Twenty head of sheep, Three sows & pigs. (This is to have
choice of all my stock, one yoke of Oxen, her choice my
Carriage & Gear, Two Beds & furniture her choice, one
Barrel, one Clock, & one years Support for her and
all her family & all her stock, to her & her heirs forever
I give unto my son Simon J. Green the balance of the
Debnam Tract of land, supposed to contain one hundred
& forty acres, more or less, one negro girl n^d Faith & all
increase from this time, also my Watch & chain, and
one hundred Dollars to be paid him out of the sales of
my land which I have loaned my wife to him & his heirs
forever; I give unto my Daughter Elizabeth J. Green one ne-
gro girl n^d Maria, & all increase from this time, one
Bed & furniture to her & her heirs forever;

I give unto my Daughter Sally J. Green all the property
she has in her possession, including negro, Rhoda, & all her
children, & all her children's children if there be any & all

increase, from this time & before, also one negro man or
Mingo, to her & her heirs forever.

I give unto the children of my Daughter Patey Kithrell
one negro man, Lem, which is now in the possession of
David Sears. (of Georgia) also one negro woman, Cotty, to
be equally divided between all her children & her heirs
forever

I give unto my Daughter Patey Kithrell Two hundred
Dollars, to be paid her out of the money arising from the
sale of my Lands to be under the entire control & manage-
ment of my Executors, at their discretion for her & her
heirs forever

I give unto my Daughter Polly Hayes all the property
which she has in her possession including negroes Sarah & all
her children which negroes are now in her possession and also
increase from this time, also negroes, Ben, & Scott, to her &
her heirs forever,

I give unto my Daughter Pessillai Shears all the prop-
erty which she has in her possession, including negroes Hannah
& all her children, which negroes are now in her possession &
all increase from this time, also, negroes, Green & Aggy, to her
& her heirs forever,

I give unto my Daughter Abigail Kithrell all the prop-
erty which she has in her possession, including all the negroes & all
increase from this time also negroes, Polly, to her & her heirs
forever

I give unto my grand son Simon Kithrell son of Abigail
one tract of Land, supposed to be Forty Acres, more or less
which Land I purchased of Joshua Kithrell adjoining the
Land of Fielding Kithrell, to him & his heirs forever

I give unto my Daughter Louisa Sears & her husband
David Sears all the property which they have in their
possession, including negroes, Aley, & Rebecca, which
negroes are now in their possession & also negroes, Peter,
& all increase from this time to them & their heirs
forever

I give unto my Daughter Ellenor Macon all the
property she has in her possession including negroes Mary
& all her children, which negroes are now in her possession
also, negroes, Ke, & Biddick to her & her heirs
forever & all increase from this time to her & her heirs
forever,

I give unto my Daughter Evelina A. Green, negroes
Betty, & her children (Richmond & ^{Gabriel} ~~William~~) Tom, & Will,
& all increase from this time, one bed & furniture &
one Walnut folding Table her choice to her & her
heirs forever,

I give unto my Daughter Eliza Green, negroes
Hardy, Milly, Billoo, Sally, & Adam & all increase
from this time, one bed & furniture (one Walnut Table
folding) her choice, three cows & calves, two sows &
pigs, ten head of sheep & one horse worth fifty Dollars
to her & her heirs forever

I also give unto Evelina A Green three cows & calves
two sows & pigs, ten head of sheep & one horse worth
fifty Dollars to her & her heirs forever

I give unto my grand son Simon G. Hayes one filly
goten by Wm Johnstons horse about one year old or
the near to him & his heirs forever

I give unto my grand son Simon Green one filly
call. Humpty, to him & his heirs forever

It is my wish that my old man Ralph live with
any one of my children that he shall prefer & that
such child shall receive out of my Estate fifty dol-
lars to enable them to treat him well.

And all my property that is not herein named &
dispos. of, consisting in what it may all sorts &
denominations whatever together with all my lands
not dispos. of, to be sold on such terms as my Execu-
tors may think best, including all debts & every other
thing or things whatever, and the money arising from
such sales & collections, after paying all my last debts
& the several legacies named within, I mean the balance
if any to be equally divided between the whole of my

children by my first wife. (or their legal heirs in
 case any should die) to each of s^d children share &
 share alike. and the part which my Daughter Patey
 Kittrell may be entitled to: be applied to her special
 benefit under the entire controul & management of
 my Executors. & after the death of Wife. the Land which
 I have Landed her. I wish to be sold in such manner
 or terms as my Executors may think best. & the money
 arising from such sale to be divided between all the
 children which I have by my first wife or their legal
 heirs Excepting my Daughter Patey Kittrell's part
 which will be under the entire controul of my Ex^{rs} for
 her special benefit. I mean that s^d Patey shall have
 a share, but to be under the entire controul of my
 Ex^{rs} for her benefit. And I do hereby nominate
 & appoint Presley C. Person. Joel King & Richard
 Ward Executors to this my Last will & Testament
 hereby revoking & disannulling all others
