to her my Negro Boy Berry during her Natural Life or Widowhood
but at her death or if she marries I allow said Negro Berry to
be the property of my Son John A. Love and his for ever
I also give to my Said Wife my Gray Horse with his Saddle & Bridle
her Birch Bureau my Walnut Table with a Draw in it one of
my chairs a Bell & a Bell pull the same on Bell to the odd

of any to be Equally Divided among my surviving Children.

furniture are bequeathed in this same Table cloth one half interest in my Threshing

Gearing Blacksmith Tools & Farming tools of Every Kind and Two Hundred
Dollars to be paid by my Executor as on the foregoing bequests toward
the last claim to Samuel W. Love his interest Wm. G. Love Whiteside Land
the foregoing Bequests to be his Right & property for ever

Item I Give and bequeath to my Son John A. Love all the tract
of Land included in my thirty acre entry and that I Bought
from Samuel Blackwood on the waters of Cowans Creek
adjoining Johnston Land and the Land already Deeded to his

I am and whereas my Son Caleb A. Love will not be 21 years
old until the year 1818 and my Son

I am and whereas my Son Caleb & Gore will not be 21 years
of age to the 25th day of March AD 1860 and my Son
Robert C G Gore will not be 21 years of age till the 15 of
Dec AD 1861 and my Son John & Gore will not be 21
years of age till the 18 of Oct AD 1866 now therefore my
will & desire is that my Brother William Gore is constated
and appointed Guardian of these my three children
to have and to hold the custody of and a Guardianship
both of their respective Persons & Estates until they severally
arrive at the age of 21 years and I do hereby constate
also and appoint my Trusty Son Samuel W Gore my General
Executor to all intents and purposes to execute this my
Last will and Testament according to the true intent and
meaning of the same and every part & clause thereof hereby
revising and declaring void all other wills & Testaments by me
heretofore made in which where I the said Andrew Gore do
hereunto set my hand & seal this twentieth day of Oct AD 1855

Govr my young mule colt I give and bequeath to my Son Robert C. Govr my young mule that I bought of I Danis also my two Large Tubs also all my cotton cloth that is now growing to be his right and property for ever I allow all my corn and all my young cattle and all my hogs and all my Sheep for the use of the Family in common for their years provision or maintenance & to purchase articles for the same I allow all Surplus and all articles whatsoever not mentioned either in this nor in my will to my wife Mary for the use of the Family I will that all my property be disposed of by my Executor as Directed in
