

being of sound mind and memory but considering the uncertainty of my earthly existence, do make and declare this my last will and testament in manner and form following, this is to say:

First, My executor (hereinafter named) shall provide for my body a decent burial suitable to the wishes of my friends and relations, and to pay all my funeral expenses, together with all just debts howsoever and to whomsoever owing out of the first money that shall come to his hands as a part of my estate. Item 1st. I Give devise and bequeath to my two sisters Jane Froneberger and Elizabeth Froneberger all my property real and personal together with all my money on hand or owing to me to them during their natural life time and after the death of the surviving one of them that then I give my share of land which is not this day deeded to J.D.L.Froneberger. I Give to L.B.Kiser and to the heirs of her body which land is bounded as follows: Beginning at a rock formerly a black gum and runs N. 75 W 112 poles to a rock on Hager's line, thence with it S.16 E. 154 poles to a stake, thence with Pasour's line East 84 poles to a poplar and rocks, thence to the beginning, containing 77 acres. Item 2nd. I Will that my personal property be sold (after the death of my said sisters) and that the money with all other money on hand and due my estate be equally divided between Adolphus Froneberger and my deceased William Froneberger's children to such as may be living at that time.

And lastly, I do hereby appoint and constitute Jacob Kiser my lawful Executor to all intents and purposes to execute this my last will and testament according to

the true intent and meaning thereof, hereby revoking and declaring utterly void all former wills and testaments by me heretofore made.
