I Am This day of the County of Gaston and
State of North Carolina being of sound mind and memory
but Considering the uncertainty of my earthly Existence do make
and declare this my last will and Testament in manner and form
following that is to say "First that my Executor herein after
named Shall Provide for my body a decent Burial Suitable to
the wishes of my Relations and Friends and pay all funeral
Expenses together with my just debts Mortuary and to whomsoever
Owning Out of the Money that may first come into his hands as
a part or parcel of my Estate —

I Give and devise to my Son Alexander H. Will the children of Negro
Woman Sparrow named Amanda and Belinda During his life Should
he die without heirs his wife Anna to hold said property during her life
at her at her deceas disse to fall back to the distribution of the Executor
to be Equally divided the amount thereof to the surviving Negroes to those
who are not Recalled any Property mentioned here else after all
Expenses are paid She to have an equal share with the Other Negroes
the Residue on Hand. I Give and devise to my Son Lewis H. Will my
Negro man Jack and Boy Richard Should he decline to dispose
of them said Negro man to have choice of his master.

I Give and devise to my daughter Mary had a bed and bedding
a Pewter Basin and Pewter Dish and half of all my household ware

I Give and devise to my daughter Anna Miller my Negroe woman

A Give and devise to my daughter Mary had a bed and bedding
a Pewter Basin and Pewter Dish and half of all my Cupboard ware
I Give and Devise to my Daughter Anne "Wilson" my Negro Woman
"Sally" and her Infant "John" Shining a Pewter Basin and half of the Cupboard
Ware and Daughter Anne her "William" A Bed and Bedding
I desire that Ezra Wilson Husband of Said Anne take into his charge
a Child of Said "Sally" named Phillis for the use and Propriety
of my Daughter Mary ^{for} she Should so Ezra Wilson feel desirous of
Retaining Said Phillis as his property he to pay Daughter Mary the
Price in Cash I desire that my horse cattle & Hogs &c be sold returning
Utensils and Kitchen Furniture also sold Should any money
Remain when Expenses are paid I direct my Executor to pay over
that amount to my Son James L Hill also I give and devise
to Sarah Hill Widow of Son John Hill ^{Hill} a sum of ~~Twenty~~ dollars —
upon her & Sarah Hill is Said ^{the} ~~the~~ James L Hill to be paid
the Remainder —

I Do hereby Constitute and Appoint
my Trusty Friend Ezra Wilson my lawful Executor to
all intents and purposes to execute this my Last Will and
testament according to the true intent and meaning of the
same and Every Part and Every Clause thereof being looking
and declaring ^{utterly} void all other Wills and testaments
by me heretofore made or witness therof
