Fifth. I will that the balance of my mill stock with all other property not already willed be sold and notes collected and divided between my son J.H.Kennedy and daughter Mary C. Torrence after paying all debts and fineral expenses.

Sixth. I hereby constitute and appoint my son J.H.Kennedy my lawful executor to all intents and purposes to execute this my last will and testament according to the true intent and meaning of the same and every part and clause thereof.
