

V. And then after the death of my beloved wife Margaret Haker, it is my will that all the rest of my personal property and real estate be equally divided among my two daughters Elizabeth Eaker, Julia Eaker And son Julius Eaker.

VI. I hereby appoint and designate my son Julius Eaker as my Executor.
