I give and bequeath to my beloved wife Alice A. Wilson, during her natural life, my house and lot on Franklin Avense, in the town of Gastonia, Gaston County, N. C. adjoining the lands of Wm. Gallant, O. M. Boyd and others, in lieu of any dower in any and all lands of which I may die seized and possessed at the death of my wife, it is my will that the said house and lot descend to my heirs at law in like manner and in such shares as if I had died intestate. Sixth. It is my will, and I hereby authorize, empower and direct my Executor hereinafter named, to sell my farm situated on the waters of "Crowders Creek" and "Little Mill Creek", in Gaston County, N. C. adjoining the lands of H.F. Forbes, the estate of Wm.M. Wilson, deceased, James Hill, W. D. 
