Carson the home place where I now reside also all the farming utensils that he may need for use in making out his crep, the others to be sold and the proceeds to be divided equally. also two horses or mules also one cow also his interest in one wheat drill also one wagon and twe (2) buggies also all the household and kitchen furniture, also all the hogs that may be a can hands also all the crop that he may have raised.

Tenth. I hereby constitute and appoint my trusted friend S.N.Boyce my lawful executer to all intents and purposes to execute this my last will and testament according to the true intent and meaning of the same and every part and clause thereof hereby revoking and declaring utterly void all other wills and testaments by me heretofore made.
