I will and direct that my Executors hereinafter mamed sell all the residue of my property, both real and personal wheresoever situated; collect and reduce to money all my classes of property in action, and divide the proceeds arising from such sales and collections equally between my six children, Jas. L. Love, M. E. Tait, Jno. F. Love, Edgar Love, Mary Love and R. A. LovE. rovided further that my brother, A. J. Love, shall have the right to occupy my farm in Texas on which he now lives during his life time free of rents.

And I do hereby constitute and appoint my sons J. F. Love and Edgar Love the Executors of this will; hereby vesting in them full power and authority

to dispose of the property described in Item Second of this will, either at private or public sale, and upon such terms and conditions as to them may seem best for my estate.
