
State of North Carolina, Tredell County.



- 4. I will and devise to my said four daughters, above named, all my lands and tenements, wherever the same may be situated, to be equally divided among them, share and share alike, to have and hold in fee sime

But if the cash on mand and personal estate shall be insufficient to pay off and discharge the several personal legacies above name and set out, then and in that case, said legacies shall be a charge on my said lands and tenements and shall be paid by my said daughters respectively, to relieve their respective shares of said real estate.

In Witness whereof, I the said R.B.Morrow, do hereunto set my hand and seal, hereby revoking and declaring utterly void all other wills and testaments by me heretofore made, this the 27" day of September, 1905.
