Item 1. I give and bequeath to my wife Rachel E. White all my real and personal property of any kind whatever.

Item 2nd. I give and bequeath to Jas. F. Weir and my daughter Mary Ida Weir one hundred acres of land bounded as follows: Beginning at a rock and runs a new line S. 77 E. 60 poles to a stone in the field, thence another new line N. 29 E. 123 poles to a rock in the old line, thence with Hovis' line N. 55 W. 55 poles to a rock, thence S. 6 W. 10 poles to a stone at the creek, thence S. 85 W. 6 poles to a rock, thence S. 10 W. 9-1/2 poles to a rock, thence S. 36 W. 8 poles to a rock, thence S. 5 W. 10 poles to a rock, thence N. 17 W. 13 poles to a rock, thence S. 73 W. 10 poles to a rock, thence N. 62 W. 74 poles to a rock, Smith's corner, thence with Smith's line S. 32-1/2 W. 52-1/2 poles

to an ash and rock, thence S. 17 E. 106 poles to a Hickory and rock,
thence S. 50 W. 57 poles to a rock, thence with Burns line W. 55 E. 84
poles to the beginning, to be theirs after the death of Rachel E. White
on the following conditions: that the said Jas. F. Weir shall remain and
live here with me and my wife as long as we both may live and take care of
myself and her and I also give them my interest in all the farming tools
also what household and kitchen furniture of my own.

Item 3. I give and bequeath the balance of my land to C.L. White,
J. O. White, F. C. White, J. C. White and my daughter H. M. Robinson to be
equally divided between them, all other personal property of any kind
whatever, to be equally divided between my six children after all funer-
al expenses have been paid of myself and wife, together with any debts
I may be owing, and lastly- I hereby constitute and appoint my son
J. O. White, Executor of this my last will and testament.
